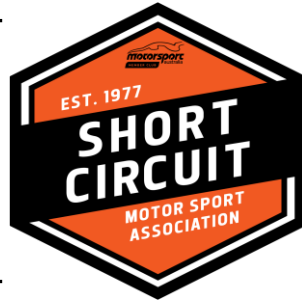

Carnell Raceway Update

Progress continues on the Carnell Raceway project. The lease documentation is currently with the solicitors, and we are awaiting final approval before it can be signed.

Once the lease is finalised, our focus will shift to rebuilding and revitalising the facility. Our initial plans include:

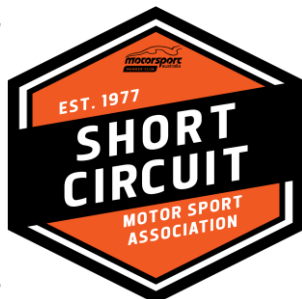
- Demolishing the existing structures that will are no longer suitable and purchasing onsite buildings to be repurposed as a kitchen and officials' office.
