Roofing Project:

- Greg Burkert, Rocklane, answered questions about SPLAT roofs & roofing project:
 - Based on the current condition of roofs (2023 study & current issues) there is no urgency to replace roofs now.
 - The Board's 13-year timetable for roof replacement agreed with Rocklane's assessment.
 - Rocklane would indeed advise SPLAT if any roofs were having habitual issues that would cause recommendation for replacement.

- Once SPLAT funds the roofing project for 2025+, Rocklane can begin within 3 week; roofing for 4 buildings will be completed in 3 weeks.
