#### TREASURERS REPORT: Ron Watson

- Pending audit exceptions report delay noted.
- Over budget accounts to date: building maintenance, drainage
- Under budget accounts to date: snow remóval; insurance deductible; roof maintenance
- Insurance costs / bids still pending.
- Possible / Potential over budget options (insurance & roofing) under consideration for August co-owner meeting consideration:
  - Assessment estimated at \$1200
  - Monthly dues increase spread over 2-3 year period

## KMC REPORT: Dan Courtney

- KMC will pay SPLAT \$14,888 for condo resale fees for 2023 sales. 2024 fees collection in place and being collected as required.

## **NEW BUSINESS:**

- Future Re-roofing Project:
  - Tim Morris of TM Engineering has developed roofing specifications per Roofing Committee guidelines
  - Re-roofing Bid requests have been sent to 5 roofing contractors for estimates by 6/30
  - Roofing plans & estimates will be part of August Co-Owners meetings to discuss forecast over-budget costs for roofing and insurance.
- Insurance:
  - Expect 3 insurance coverage from 3 companies by 7/30.
- Kretz development:
  - Trees/shrubs removed at the front of Kretz property by Kretz has been donated by him to SPLAT. These items have been temporarily planted for future placement. Many thanks to Tom Kretz.
- New policy definition has been approved for inclusion in the handbook under Exterior Modifications: Cutting a hole in the exterior of a condo requires architectural approval of the Board.
