TERMS AND CONDITIONS OF CREDIT AND SALES**

By submitting this credit application _____ (hereinafter referred to as "Purchaser") Authorizes Pelican Construction Supplies of Baton Rouge DBA CASCO (hereinafter referred to as "Seller") to inquire into the credit and banking references disclosed on the front page of this application and hereby agrees to be bound to the following terms and conditions which shall govern all purchases.

1. Seller will not be obligated to extend credit to Purchaser until this application has been submitted and Purchaser's credit approved by Seller's home office at 15207 Airline Highway, Baton Rouge, LA 70817.
2. No credit application shall be processed by Seller unless accompanied by Purchaser's resale tax license for each state the Purchaser conducts business.
3. Each order for Seller's products by Purchaser shall be considered a separate transaction and the terms for payment shall be net 30 days from date of invoice unless prior arrangements have been made with the Seller.
4. All balances not paid within the time specified above are subject to a late charge of 1.5% per month (18% per annum).
5. On default of any payment required under the terms and conditions as set forth above, Seller may, at its option, cancel any unfilled portion of any outstanding purchase order, and at Seller's option, all sums outstanding shall become immediately due and payable.
6. If it becomes necessary for Seller to obtain the services of an attorney to secure collection of this account, Purchaser agrees to pay all costs incurred, including court costs and reasonable attorney's fees.
7. The undersigned hereby agrees to the selection of Baton Rouge as the proper venue for filing any law suit for collection as referred to above, and expressly waives any claim or right to have any such lawsuit placed in any other county or state.
8. In the event Purchaser is a corporation or partnership, the undersigned represents that he has the lawful authority to bind said corporation or partnership for the payment of all sums due as set forth.
9. In the event Purchaser is a corporation or Limited Liability Corporation, the undersigned, in order to induce Seller to extend credit to Purchaser, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby unconditionally and irrevocably personally guarantees the prompt payment to Seller of the purchase price for all of Seller's products purchased from Seller and all other amounts payable under the terms and conditions as set forth above.
10. This agreement is to be governed and construed in accordance with the laws of the State of Louisiana and shall be binding upon both parties, their successors or assigns.
11. In the event any of the terms and conditions as set forth above are determined by a court of competent jurisdiction to be invalid or unenforceable, said determination shall not affect or impair any other terms and conditions herein.
12. The undersigned personally guarantees payment of all obligations of applicant to Pelican Construction Supplies of Baton Rouge DBA CASCO.
