Putting more money directly in your pockets

Whether it's filling up at the pump or paying for groceries, families here in Vaughan-Woodbridge and across Canada are struggling to keep up with the rising expenses for their families.

Our government is committed to making life more affordable for everyone. The first thing our government did this fall was to introduce new measures to help you and your family. We are putting more money directly in your pockets by:

1. Starting in early November, we are doubling the GST tax credit for six months, putting more money back in the pockets of Canadians — on average **up to \$234 for single Canadians without children, up to \$467 for families, and up to \$225 for seniors.**

This is targeted support to the roughly 11 million individuals and families who already receive the tax credit, including about half of Canadian families with children and more than half of Canadian seniors. Canadians who are eligible will automatically receive the credit.

2. We are introducing a Canada Dental Benefit to provide up to \$1,300 over two years for children under 12, starting this year - while a comprehensive national dental care program is developed.

Every Canadian deserves good oral healthcare, and we will continue working with all partners to improve access.

3. We are sending a one-time \$500 payment to nearly two million renters who are struggling with the cost of housing.

The federal benefit will be available to applicants with an adjusted net income below \$35,000 for families or below \$20,000 for individuals, who pay at least 30 percent of their income on rent.

This targeted relief supports the steps we've already taken this year to make life more affordable for Canadians.

Did you know that our government is

- **Raising the Canada Workers Benefit to put up to \$2,400 more into the pockets of low-income, minimum-wage families starting this year;**
- **Increasing Old Age Security by 10% for seniors 75 and over**, providing an additional \$800 to more than three million seniors, which started in July;
- **Cutting child care fees by an average of 50% across the country by the end of this year** and creating 86,000 new child care spaces in Ontario; and,
- **Tying key benefits to inflation so they keep up with the cost of living**, including the Canada Child Benefit, the GST Credit, the Canada Pension Plan, Old Age Security, and the Guaranteed Income Supplement. The federal minimum wage, which we increased to \$15/hour, is also now tied to inflation.





Peter Sandica “The Man of Vision & Success”

Arriving in Canada from Romania in 1994 Peter Sandica was only twenty-five years old. He decided to venture to Canada because of all the political issues in Romania after breaking up from a communist regime for forty-five years. Peter served in the Romanian Navy for twelve years before he came to Canada and began his career at age 14 being admitted to the Military Marine high school of Romania. The selection of students at the time was very demanding consisting of a physical exam, medical exam, and a written test. Peter’s determination to success was very strong. He became the second on the admission list competing with 4000 applicants for 120 enrolment spots. After Four years of high school, he continued three more years in the Naval Institute specializing in naval rockets and artillery. At the age of twenty-three Peter was selected to be part of the crew responsible to bring home to Romania two new ships from the USSR. To Peter, immigrating to a different country thirteen thousand miles away from home, is like being born for the second time. Peters’ education included learning several languages, and English was not one of them.

Renting an apartment in North York and determined to learn English he bought a TV with closed captioning which would help him learn the language. After four weeks in Toronto, he got his first job, making ten dollars per hour

and a few years later, he began working for a restoration company as a subcontractor. In 2002 his General Contracting company became very successful because of his expertise in restoring houses and commercial units. His company Salco General Contracting became a major company in the restoration business employing 22 carpenters, painters, tapers and flooring installers.

In 2009 the recession impacted his company, Salco General Contracting, by having fewer completed contracts. Peter lost most of his employees because of the shortage of work caused by the recession in 2009. Not giving up

his hopes in business two years later, Peter purchased an American restoration franchise. Now the General Contracting company was transformed into a full-service restoration company providing emergency services and complete reconstruction for their customers. After Nine years the company had four different locations in the GTA: Markham, Richmond Hill, Vaughn and Mississauga. During that time the firm completed over three thousand projects in restoration and construction.

In 2019 the company renamed itself as the **RENOLUX RESTORE GROUP** in order to expand its operations. By contracting their clients to manage moving from larger homes to condominiums, he created **RENOLUX DESIGN** as part of the **RENOLUX RESTORE GROUP**. This division provides white glove services to homeowners and delivers a “no worries experience”. Peter’s involvement with the Vaughan Chamber of Commerce created an opportunity to join the Mayor of Vaughan and 22 business leaders to a trade mission trip in Israel. There he was introduced to a state-of-the-art disinfection sterilization system developed by DARPA - American Defence Authority for anthrax attacks in 2001. Peter, returning to Canada, immediately incorporated a company called Ster-OL Infection Control using the state-of-the-art disinfection/sterilization system. This company provides sterilization services for several municipalities as a preferred vendor. During the pandemic, Ster-OL was servicing industries including medical, nursing homes, condominiums, houses, restaurants, and offices. Ster-OL has the capability to perform disinfection service within one hour after receiving the service request. This service provides no-touch sterilization, with no-residue and no-odour. One certified technician can disinfect 10,000 square feet per hour and the company has capacity to service two million square feet

at any given time. The cost of sterilization can vary from \$0.08 to \$0.25 per SF and is provided throughout Ontario. During the pandemic Ster-OL was involved in case studies for disinfecting ambulances and it is able to sterilize one ambulance in 12 minutes versus 4 1/2 hours of conventional cleaning. Peter immediately built in their own warehouse a drive-in ambulance/emergency vehicle sterilization room. Wanting to help the medical industry on the shortage of N95 mask he built a portable sterilization unit to sterilize N95 masks and face shields. This state of art technology helped the company to obtain various sterilization contracts with some major developers in the GTA. Some major jobs completed by **RENOLUX RESTORE GROUP** are: 2013 flood -300 houses cleaned and restored; 2015 - meth lab clean-up of 42 apartments affected; 2017 - explosion in Mississauga - 27 townhouses affected. Peter’s companies acquired all verification certificates required in the restoration industry. His involvement with the Vaughan Chamber of Commerce brought him closer to the business community as the Vice Chair of the board. Peter Sandica’s goal is to build and achieve more in insurance products, luxury renovations, property management and infection control.

His profound advice is to always dream high and look for opportunities. In a quarter of a century, Peter learned how

Recently he returned from a 35-year high school reunion from Romania and thought “wow, what an exciting experience to see his colleagues after more than three decades.” Peter is the only successful businessman overseas out of all his school colleagues who loved to hear his successful story. All his achievements would not be possible without the support of his business partner and wife Felicia. They have three children 13, 15 and 23 years

to be a leader and a mentor. For him to be a leader means to always have a team beside you. He believes that we are nothing without a strong team. Peter stated, “people are working with me and not for me”. He considers his employees like they are his extended

Happy to Have Sponsored Bill C-30 in the Senate, Delivering Support to Over 11 million Households

The Government is mindful that millions are struggling to make ends meet which is why it introduced two important pieces of legislation immediately upon our return from the summer recess, including Bill C-30, the Cost-of-Living Relief Act No. 1, which doubles the Goods and Services Tax Credit for six months. I was honoured to sponsor and shepherd this bill through the Senate.

Inflation is making life increasingly more unaffordable for Canadians. For many, the cost of living is forcing them to make difficult decisions, sometimes heart wrenching ones, that could have a significant impact on their lives and the health and wellbeing of their children.

Just last week, Statistics Canada reported that the Consumer Price Index rose 6.9% on a year-over-year basis. Since its peak in June at 8.1%, there have been three consecutive months of lower inflation, a sure sign that the Bank of Canada's interest rate hikes are achieving early and encouraging results, and yet, the price of food, shelter and energy continues to be higher-than-usual. We've all seen the impact at the grocery store: we are paying 7.6% more for meat, 9.7% for dairy products, 11.8% for fresh vegetables, and 14.8% more for bakery products.

According to the Government, over 11 million Canadian households will benefit from this temporary top-up of the GST Tax rebate. This measure is targeted to individuals and families with lower or moderate incomes. Depending on the size and income of your household, Canadians could receive hundreds of additional dollars, which could go a long way in paying for the higher cost of groceries, rent and energy. Half of Canadian families and more than half of Canadian seniors are expected to benefit from this extra money.

To receive this benefit, it's important to take note that Canadians must file their income taxes with the Canada Revenue Agency. The payment will be automatic to eligible recipients, and the first top-up installment is expected to reach Canadians before the Holidays.

The expectation is that this measure will cost \$2.5

billion. Some have argued that injecting this sum of money into the economy will generate even higher inflation. There's no doubt that increasing money supply can have an impact on inflation. However, many experts including Mark Carney, former Governor of the Bank of Canada, and Yves Giroux, the Parliamentary Budget Officer, have both confirmed that this amount should not increase inflation.



As Mr. Carney told me at our Banking Committee last week, relative to the size of the Canadian economy (over \$2 trillion), the injection of \$2 billion should have little effect on inflation. However, he did stress and caution that the accumulation of \$2 billion investments can start to add up which is why fiscal discipline is needed. I completely agree with him.

As I asserted in my second reading speech in the Senate, the measure contained in Bill C-30 is clear, simple, and targeted. It's designed to help the most vulnerable in our community and, in my view, is an appropriate answer to the current period of unusual and extraordinary economic challenges that many Canadians are facing.

I think it strikes the appropriate balance between delivering support where and when it is needed the most and maintaining the discipline that has given Canada a strong fiscal position, while not undermining efforts to bring inflation down. As Minister Freeland told Senators earlier this month, Canadians are cutting back on costs right now, and the Government needs to do that too, which is why this measure is targeted and not broad in scope.

In the end, I'm happy to report that Bill C-30 was adopted by both Houses of Parliament and received Royal Assent on October 18th. Millions of Canadians can expect a little extra money in the coming months.

As I said in the Chamber, if getting this bill adopted now means that families across this country may enjoy a better meal at Christmas, or some child might receive a new winter snowsuit, or parents can turn up the heat a little higher during our cold winter months, I'm certainly willing and happy to sponsor and vote in favour of this bill.



POWER OF ATTORNEY

The importance of wills and power of attorney

Now is the perfect time to make plans for things that are inevitable. Death, taxes and financial uncertainties are experiences which everyone will go through at some time in their lifetime.

My name is Nella Macchia. I am a Lawyer who lives and practices in Vaughan. I am fluent in English and Italian. I was born in Calabria and went to school there for two years. I have been practicing Law for 35 years.

As a trusted Lawyer and advisor, it is more important now than ever before for everyone to plan because of the rapid changing environment in which we live. Reduce stress by creating an Estate Plan which speaks for you when you can no longer speak in order to carry out your last instructions.

Angus Reid conducted a poll in 2018 which found that 51% of Canadians had no last Will and Testament and that 35% had a Will which was not up to date and only 40% of Canadians had a Powers of Attorney in place.

What is the difference between a Will and Powers of Attorney?

A will only takes effect on death. If there is no death and the person is capable, they can change their Will. A Power of Attorney allows someone they trust to make decisions for them, such as property or personal care, while they are alive but not capable. In effect, the Powers of Attorney allow the named Attorney to pay bills, mortgage, sell your property, arrange for nursing care etc.

Another misconception of which I come across in my practice is that many assume that their property will automatically go to their spouse or children on death. This is not necessarily true. If you do not have a valid Will in place, there is written legislation which dictates who will benefit from your estate. For example, if you do not have a spouse or children, or parents alive, your next of kin including brother, sister or cousin would be entitled to your estate.

Without a valid will your estate is subject to litigation between competing persons who may apply to the courts to be your Estate Trustee. This could happen because you failed to make clear your preference of who you trust to be the executor of your last testament. This would result in litigation between parties who may not necessarily have your best interest at heart causing stress, time consumption and a great deal of expense for all parties involved.

Every person, 18 years or older should have both a Will and Powers of Attorney in place.

Statistics Canada did a study and found that for younger Canadians, 35 and under, only 23% had a Will and only 9% had Powers of Attorney in place. Assuming this younger Canadians group have minor children who are dependent on them and in the event of death many questions would have to be addressed to your attorney. Without a Will and Powers of Attorney no individual can claim to be the executor of the will. While these are difficult discussions to have between parents, families should put their estate in place so that their children are protected and their future affairs are organized to their benefit.

The average age of Canadians is on the rise. It appears that even in this older age group have prepared a Will and Powers of Attorney, but a significant number are not up to

date and do not meet their current wishes. This senior age group is also failing to take action to ensure that their will reflects their current wishes.

One must keep in mind that Internet based will kits do not necessarily apply to the country in which one lives. Some internet wills are based on American laws which do not apply in Canadian laws which the courts will not validate.

If you are going to make an estate plan, you need to get professional advice in regards to the various types of assets you own which includes home, bank accounts, rrsp's, insurance, pension income, inheritance etc. With professional planning you can arrange your affairs, in order to minimize the tax liability on death. An individual may not be aware that holding property with a spouse jointly can ensure there is no Estate Administration Tax on the jointly held asset until a much later date. In addition there exists also a Spousal rollover in the Tax laws which allows a spouse to name their spouse as the designated beneficiary of their RRSP for the account to be transferred without having taxes withheld by the bank. There are other tax legislative rules which can be used to preserve wealth and delay or postpone income taxes.

Conclusively it is best for everyone to have a Will and Powers of Attorney in place and review them from time to time.





Japan's Toyota - is currently the world's largest automaker.

Toyota and Volkswagen vie for that title each year -- each taking the crown from the other -- as the market moves. GM -- America's largest automaker -- is about half Toyota's size -- thanks to its 2009 bankruptcy and restructuring. Actually -- Toyota is a major car manufacturer in the U.S. In 2016 about 81% of the cars it sold in the U.S. came off American assembly lines.

Toyota was among the first to introduce gas/electric hybrid cars with the Prius twenty years ago. The company hasn't been afraid to change the car game.

All of this is to point out that Toyota understands both the car market and the infrastructure that supports the car market. Probably understands better than any other manufacturer on the planet.

Toyota hasn't grown through acquisitions as Volkswagen has, and it hasn't undergone bankruptcy and bailout as GM has. Toyota has grown by building reliable cars and trucks for decades.

When Toyota offers an opinion on the car market it's probably worth listening to.

This week Toyota reiterated -- The world is not yet ready to support a fully electric auto fleet.

Toyota's Robert Wimmer (head of energy & environmental research) said this week in testimony before the U.S. Senate, "If we are to make dramatic progress in electrification it will require overcoming tremendous challenges - challenges including: refueling infrastructure/battery availability /consumer acceptance / and affordability."

Wimmer's remarks come on the heels of GM's announcement that it will phase out all gas internal combustion engines (ICE) by 2035.

Tellingly, both Toyota and Honda have so far declined to make any such promises. Honda is the world's largest engine

manufacturer (when you include: boats / motorcycles / lawnmowers / etc) Honda competes with Briggs & Stratton in those markets amid increased electrification of [traditionally gas powered] lawnmowers / weed trimmers /etc

While manufacturers have announced ambitious goals just 2% of the world's cars are electric at this point.

Buyers continue to choose ICE over electric because of: price / range / infrastructure /affordability / etc. Only a small percentage of people would choose an electric car unless forced to by

There are 289.5 million cars just on U.S. roads as of 2021. About 98 percent of them are gas-powered.

Toyota's RAV4 took the top spot for purchases in the 2019 U.S. market -- Honda's CR-V is second and GM's top seller (Equinox) comes in at #4 behind the Nissan Rogue. GM only has one entry in the U.S. top 15. Toyota and Honda dominate - each with a handful in the top 15.

Toyota warns: the US electrical grid and infrastructure simply aren't there to support the electrification of the private car fleet. A 2017 U.S. government study found we would need about 8,500 strategically-placed charging stations to support a fleet of just 7 million electric cars.

That's about six times the current number of electric cars. But no one should be talking about supporting just 7 million cars.

We should be talking about powering about 300 million within the next 20 years if all manufacturers follow GM and stop making ICE cars.

We are gonna need a bigger energy boat to deal with connecting all those cars to the power grids - a WHOLE LOT bigger boat. But instead of building a bigger boat we may be shrinking our boat. Power outages in California and Texas have exposed issues with power supplies even at current usage levels.

Increasing usage of wind and solar, -- both of which prove unreliable -- has driven some coal and natural gas generators offline

We will need much more generation capacity to power about 300 million cars if we're all going to be forced to drive electric cars, and we will be charging them frequently. Every roadside gas

station must be wired to charge electric cars and charging speeds must increase greatly

Current technology allows charges in “as little as 30 minutes” - but that best-case fast charging cannot be done on home power. Charging at home (on alternating current) takes a few hours to overnight and will increase the home power bill.

That power, like all electricity in the United States, comes from generators using: natural gas /petroleum/coal/nuclear/wind/solar/or hydroelectric sources.

Even half an hour is an unacceptably long time to spend charging. It's about 5 to 10 times longer than a gas pump takes. Imagine big rigs with much larger tanks. Imagine the charging lines that would form every day if charge time isn't reduced by 70 to 80 percent.

We can expect improvements but those won't come without cost. Electrifying the auto fleet requires massive overhaul of the power grid and an enormous increase in power generation. Toyota has publicly warned about this twice while its smaller rival GM is pushing to go electric. GM may be trying to win favor with those in power in California/ Washington / and in the media.

Toyota's addressing reality, and they know what they are talking about.

Toyota isn't saying none of this can be done. They are saying that conversations are not anywhere near serious and will not produce meaningful results.
