I acknowledge that if I lose or damage lifejackets, paddles, paddle board pump, kayak or paddle board, the following expenses stated below will be my responsibility.

Paddle Replacement: \$75.00/each; Fin Replacement: \$50; Lifejacket replacement: \$60.00/each; Kayak Seat: \$100; Clear Kayak Replacement: \$ \$2,000.00; Paddle board Replacement: \$1,500.00; Repair to Kayak & Paddle Board: \$150.00/minimum; Ankle Strap Replacement: \$30

Kayak/Paddle board Rules:

- 1) Do not use paddles to push off the bottom, as it may break the ends of paddles.
- 2) No dragging kayaks/paddle boards across gravel, pavement, concrete or any hard surface as it can cause damages.
- 3) I will have the kayak/paddle board clean and ready for pick up or be subject to a \$10.00 cleaning fee.
- 4) Equipment rented and not used due to weather or returned early will not be refunded.

Renter's Duties and Obligations

- 1) Renter understands the Renter is hereby assuming responsibility for all persons in Renter's party, whether adults or minors, utilizing any of the equipment, and for their acts which may cause damage or injury to property or persons. Renter is in good health, not under the influence of alcohol or drugs and is otherwise capable of safely operating the equipment provided.
- 2) I am aware that Stand Up Paddle boarding ("SUP") and/or kayaking poses potential risks and I am aware of the dangers of SUP/kayaking. That in consideration of being permitted to use the equipment being provided by T.T Water Sports, I am prepared to bear the costs of all risks, injuries, or damages known or unknown that may be created by renting or using any equipment. I undertake to assume full responsibility for any risk, injuries or damages, known or unknown, which I might incur as a result of the use of said equipment.
- 3) Please treat our equipment as if it were your own or better. We take pride in our equipment and hope you will enjoy and appreciate the value and performance. Be sure to rinse off all equipment with fresh water after every use and store them in a cool area. DO NOT leave SUP/Kayak lying in the sun or on the beach unattended.
