

- 1.2. **‘BSE’** is the abbreviation for BSE Limited being the only stock exchange on which the Equity Shares of the Target Company are listed.
- 1.3. **‘Equity Shares’** means fully paid-up equity shares of face value of ₹10.00/- each.
- 1.4. **‘Identified Date’** means the date falling on the 10th Working Day prior to the commencement of the Tendering Period for the Offer, for the purposes of determining the Public Shareholders to whom the Letter of Offer shall be sent. It is clarified that all the Public Shareholders (registered or unregistered) who own Equity Shares are eligible to participate in this Offer at any time before expiry of the Tendering Period.

- 1.10. **‘Offer Period’** means the period from the date of entering into an agreement, to acquire the Sale Shares, and Voting Share Capital in, or control over, the Target Company requiring a Public Announcement or the date on which the Public Announcement has been issued by the Acquirer, i.e. Monday, December 02, 2024, and the date on which the payment of consideration to the Public Shareholders whose Equity Shares are validly accepted in this Offer, is made, or the date on which this Offer is withdrawn, as the case may be.

- 1.14. **‘Public Shareholders’** shall mean all the public shareholders of the Target Company who are eligible to tender their Equity Shares in the Open Offer, excluding the Acquirer, the existing Promoters of the Target Company, i.e., the parties to the Share Purchase Agreement, and persons deemed to be acting in concert with such parties.
- 1.15. **‘Sale Shares’** collectively refers to 4,85,730 Equity Shares representing 6.50% of the Voting Share Capital of the Target Company, to be acquired from the Selling Promoter Shareholders.
- 1.16. **‘SEBI’** means Securities and Exchange Board of India.
- 1.17. **‘SEBI (ICDR) Regulations’** refers to Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 and subsequent amendment thereto.
- 1.18. **‘SEBI (LODR) Regulations’** refers to Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and subsequent amendment thereto.
- 1.19. **‘SEBI (SAST) Regulations’** refers to Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and subsequent amendment thereto.
- 1.20. **‘Share Purchase Agreement’** or **‘Underlying Transaction’** refers to the share purchase agreement dated Monday, December 02, 2024, executed between the Acquirer and the Selling Promoter Shareholders, pursuant to which the Acquirer has agreed to acquire 4,85,730 Sale Shares representing 6.50% of the Voting Share Capital of the Target Company, at a negotiated price of ₹2.00/- per Sale Share, aggregating to a maximum consideration of ₹9,71,460.00/-, payable subject to the terms and conditions specified in the said Share Purchase Agreement.
- 1.21. **‘Target Company’** or **‘PFLINFOTC’** refers to M/s PFL Infotech Limited, a public limited incorporated under the provisions of the Companies Act, 1956, bearing corporate identity number ‘L72200TG1993PLC007005’, bearing Permanent Account Number ‘AACCP7177N’ allotted under the Income Tax Act, 1961, with its registered office located at House Number 1-10-122-125/B-2/, Flat No.102, Block B2, Radha Krishna Towers, Mayuri Marg, Begumpet, Hyderabad, Secunderabad – 500016, Telangana, India.

- 1.22. **‘Voting Share Capital’** shall mean the total voting Equity Share capital of the Target Company on a fully diluted basis expected as of the 10th Working Day from the closure of the Tendering Period for the Offer.
- 1.23. **‘Working Day’** refers to the day which shall have the meaning ascribed to it under Regulation 2(1)(zf) of the SEBI (SAST) Regulations.

2. OFFER DETAILS

Assuming full acceptance under this Offer, the aggregate consideration payable to the Public Shareholders in accordance with the SEBI (SAST) Regulations will be ₹38,88,612.00/-, that will be offered to the Public Shareholders who validly tender their Equity Shares in the Offer.

- 3.2. This Underlying Transaction by itself does not and will not result in the Acquirer acquiring more than 25.00% of the Voting Share Capital of the Target Company. However, pursuant to this Offer, the Acquirer may hold 25.00% or more of the Voting Share Capital if the number of Offer Shares are fully tendered and accepted in this Offer aggregating to 32.50% of the Voting Share Capital of the Target Company. Hence, this Offer is a triggered mandatory open offer in compliance with the provisions of Regulations 3 (1) and 4 of the SEBI (SAST) Regulation pursuant to the execution of the Share Purchase Agreement for acquisition of substantial number of equity shares, voting rights, and control over the Target Company.
