**A RESOLUTION OF ELLISPORT BAY SEWER DISTRICT, OF BONNER COUNTY, IDAHO, INCREASING O&M FEES (ACTIVE ERUS) BY 5% AND IER FEES (INACTIVE ERUS) TO BE INCREASED TO \$47.86 PER MONTH TO MATCH THE O&M FEES (ACTIVE ERUS)**

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF ELLISPORT BAY SEWER DISTRICT, of Bonner County, Idaho, as follows:

WHEREAS, Ellisport Bay Sewer District is a taxing district as defined by Idaho Code Section 63-3101; and

WHEREAS, the governing board of the District has tentatively approved the budget for the fiscal year 2023-2024 to allow for collection of Sewer Facility and/or Operating and Maintenance fees pursuant to Idaho Code Section 42-321 (1); and

WHEREAS, the District has identified its anticipated expenses and revenues for such fiscal year and,

WHEREAS, the anticipated expenses are such that an increase in operations and maintenance fees are necessary and,

WHEREAS, a public hearing has been held to receive public comments and to explain the reasons for increasing said fees pursuant to Idaho Code Section 63-1311A; and;

NOW, THEREFORE, BE IT RESOLVED THAT the District hereby approves increasing for the fiscal year 2023-2024 operations and maintenance fees for O&M fees (Active ERUs) by 5% and IER fees (Inactive ERUs) to be increased to \$47.86 per month to match the O&M fees (Active ERUs). Rate increases effective January 1, 2024.


