The long-stalled Hicksville downtown revitalization plan is beginning to move again after Oyster Bay and New York State officials agreed upon a revised set of projects.

The state will provide \$8.7 million in grant money to pay for infrastructure improvements and openspace projects around the Hicksville Long Island Railroad station. Town Supervisor Joseph Saladino said Monday that construction is expected to begin in the summer.

The changed plan "keeps in line with the spirit of the DRI [Downtown Revitalization Initiative] award," Saladino said in an interview.

"We are thrilled that these have been approved after much input from the public and quite a bit of community input to this," Saladino said. "We think that these projects are going to be phenomenal in redesigning the experience in downtown Hicksville."

The revised plan would expand John F. Kennedy Memorial Park into parking spaces directly to the south and create a Festival Plaza nearby by adding plantings and seating to land being used as surface parking. Both were in the original plan but had been conceived of as being larger open spaces.



By Ted Phillips, November 8, 2022 The Long Island Rail Road's nearly 10-mile-long Third Track through Nassau County is done, officials announced Monday morning.

The \$2.5 billion effort had been considered and debated by Long Island planners for more than six decades before construction began in 2019.

"This is the completion of a long, long ride," Gov. Kathy Hochul announced at a news conference at a garage adjacent to the LIRR's Westbury Station. The crowd included key figures from the project's long history, including two former LIRR presidents and the current interim president.

The new track, stretching from Floral Park to Hicksville, has long been seen as critical to the expansion of the LIRR, which has operated on the same two tracks through its bottlenecked Main Line for more than a century. The constrained infrastructure limited the railroad's ability to run eastbound trains during the morning rush hour, westbound trains in the evening, and to work around unexpected service disruptions along the busy line, which connects to Ronkonkoma, Huntington, Port Jefferson, Hempstead, and Oyster Bay. Combined with its also soon-to-be-completed East 12:49 PM Side Access megaproject, the LIRR says it will boost service by 40% and, for the first time, be able to provide adequate service to "reverse commuters" traveling to and from jobs on Long Island.


