## PURCHASE CONTRACT

This is a Bill of Sale and Purchase Agreement for ONE Olde English Bulldogge puppy. This puppy is registered with the International Olde English Bulldogge Association (IOEBA).

## CONDITIONS & TERMS

1. Buyer agrees to register puppy with the IOEBA and MUST list Boulder Mountain Bulldogges as the puppy's Producer and the prefix on the puppy's registered name. (*for example: If the puppy's name will be "Spike", the registered name must be either "Boulder Mountain Bulldogges' Spike" or "Boulder Mountain Spike". Any variation of Producer name on registration must be approved in writing PRIOR to use.*)
2. Puppy will have been wormed and received vaccination(s) depending on age, and shot records are included in puppy file. Buyer understands that vaccination against diseases both viral and bacterial, does not guarantee that the animal will not contract a disease. It is the Buyer's responsibility to keep the puppy away from sick/unhealthy animals or areas that may be infected. **\*\*NOTE: Puppy has been vaccinated at least once against PARVOVIRUS. This DOES NOT guarantee that they are immune and extreme caution is to be used when socializing puppy and visiting high-animal traffic areas. BMB DOES NOT GUARANTEE AGAINST PARVOVIRUS AFTER TRANSFER OF OWNERSHIP.**

3. The puppy is guaranteed to be in good physical condition at the time of shipping or transfer and for up to 48 hours afterward. Buyer agrees to have a complete physical examination of the puppy at their expense, performed by a licensed Veterinarian within two (2) business days of receipt. **ANY** vaccinations or medications administered to the puppy within this 48hr period may void this guarantee. If in this exam the veterinarian finds that the puppy has a serious physical defect in the heart, lungs, liver, kidneys or severe hip dysplasia, diagnosing vet will provide written certificate stating the exact defect present and severity of said defect. Boulder Mountain Bulldogges (BMB) maintains the right to have their veterinarian examine the puppy and, if both vets are in agreement regarding diagnoses and severity, agrees to replace the puppy with another puppy of equal value or refund monies paid solely at their discretion. (Serious physical defects DO NOT include common bacterial/viral infections which are treatable, including but not limited to Coccidia or Giardia) Buyer understands that accidents and illnesses can and do occur, and that BMB will not be responsible for injury or illness resulting from such once transfer of care is complete. Buyer further understands and agrees that any and all expenses related to health and/or veterinary care for ANY reason are their sole responsibility and will NOT be refunded by BMB.
4. Boulder Mountain Bulldogges reserves the right to refuse or cancel the sale of a puppy to anyone at any time, for any reason regarding the welfare of the puppy. In the event that BMB chooses to cancel the sale of a puppy, all monies will be refunded to the buyer IN FULL, including any deposits received with the exception of shipping costs and/or any other sale specific costs incurred and documented within this contract.
5. A **NON-REFUNDABLE** deposit is required to hold your puppy. Puppies are reserved on a 1<sup>st</sup> come (1<sup>st</sup> deposit received), 1<sup>st</sup> served basis. The puppy must be paid for IN FULL by 8 weeks of age (date: \_\_\_\_\_). If BMB has not received payment for the entire agreed upon cost of the puppy by 8 weeks of age, Buyer will be notified of a 72-hour “grace period” in which to fulfill contract obligation. If payment in full has not been received by the end of the grace period or suitable arrangements made in writing, Buyer forfeits puppy reservation and all monies paid to date.
6. Buyer agrees to pick up puppy by 9 weeks of age or a \$25.00/week boarding fee will be charged along with any other expenses incurred including veterinarian checks, vaccinations, etc., payable at pickup. If Buyer has not picked up puppy by 12 weeks of age without suitable arrangements made and agreed upon in writing, Buyer forfeits the puppy and all monies paid to date.
7. All payments must be received IN FULL as specified above before puppy will be released and transfer of ownership granted. Accepted forms of payment include:
  - Cash – in person ONLY
  - Money Order made payable to: Tanya D. Martinez
  - PayPal (add 3% for fees)

- Personal Check made payable to: Tanya D. Martinez (must clear my bank prior to txf of puppy)

8. Shipping is available and can be arranged by Boulder Mountain Bulldogges. ALL shipping and associated costs must be paid for by Buyer and received/cleared PRIOR to shipping.

LIMITED REGISTRATION Buyer agrees to abide by the following stipulations:

- a) Buyer will have the puppy spayed/neutered PRIOR to puppy's 2 year birthday (date: \_\_\_\_\_). (We recommend waiting at least 1 year or after 1st heat for hormonal and physical development.) Certificate of proof of alteration by a licensed veterinarian is mandatory and must be sent to BMB within 30 days of the procedure.
- b) If the puppy is bred without the written permission of Boulder Mountain Bulldogges, whether by accident or by design, Buyer forfeits ownership and any and all rights to puppy, any offspring it may have, and all monies paid. Ownership of puppy will revert back to Boulder Mountain Bulldogges immediately. Stipulation enforcement will be at the sole discretion of BMB.

FULL REGISTRATION Buyer agrees to abide by the following stipulations:

- a) FEMALE PUPPY:
  - i. Buyer will not allow puppy to be bred before her 2<sup>nd</sup> heat cycle or 1 full year of age.
  - ii. Buyer will not breed puppy on more than two consecutive heat cycles.
  - iii. Buyer must only breed this animal to another purebred Olde English Bulldogge.

- iv. *If/when the decision to breed is made, Boulder Mountain Bulldogges will be notified in written form prior to breeding.*
- v. *Buyer will comply with IOEBA's "Breeder Code of Ethics".*

b) *MALE PUPPY:*

- i. *Buyer will not allow puppy to breed prior to 1 full year of age.*
- ii. *If/when the decision to breed is made, Boulder Mountain Bulldogges will be notified in written form prior to breeding.*
- iii. *Buyer must only breed this animal to another purebred Olde English Bulldogge.*
- iv. *Buyer will comply with IOEBA's "Breeder Code of Ethics".*

10. Buyer agrees that this puppy will never be abused, neglected or used for illegal or unethical purposes of any kind. Buyer also agrees to provide proper shelter, food, water for the puppy and that the puppy will not be left on a chain for extended periods of time. Buyer commits to provide necessary veterinarian checkups and vaccinations. If the puppy ever shows signs of neglect or abuse, ownership of puppy will immediately revert back to Boulder Mountain Bulldogges without any return of monies received.

11. Producer understands that circumstances change. In the event that the Buyer can no longer own this dog or provide necessary and/or proper care, Buyer agrees to return animal to Boulder Mountain Bulldogges without return of monies paid. Buyer further agrees that the puppy WILL NOT be placed in an animal shelter or breed rescue.

12. Buyer guarantees that this puppy will never be given or sold to any individual, organization, company or research facility without first obtaining the written permission of Producer.

TERMS: The term of this contract is valid for the life of this puppy. Failure to abide by any and all of the conditions set forth herein will result in immediate revocation of ownership of animal without refund of monies paid along with civil and/or criminal charges or litigation as appropriate.
