Health and vaccination details

Reason for rehoming or adoption interest

NGO certification or ID proofs

d. Automated Data

IP address

Browser type and version

Device type and usage logs (cookies or analytics, if applicable)

3. How We Use Your Information

Your information is used strictly for service-related purposes:

To connect adopters and rehomingers

To validate legitimate pet listings

To maintain transparency between parties

To contact you for clarifications, approvals, or status updates

To maintain internal records and improve our services

We **do not** sell, rent, or trade your personal data for marketing or profit.

4. How Your Information is Shared

We may share necessary details:

With verified NGOs or adoption homes (when required for adoption facilitation)

With shelters if you submit a pet for rehoming

With legal authorities if required under compliance or in case of fraud/misuse

All form submissions are processed via secure channels and shared **only with the admin (gaurangwadhawan3@gmail.com)** for further action.

5. Data Protection & Storage

All data is encrypted in transit using HTTPS.

Uploaded files (like ID proof or medical records) are never stored publicly.

We use trusted platforms (like FormSubmit) for email-based submission which auto-deletes data after a limited retention period unless specified otherwise.

6. Cookies and Tracking

Currently, we **do not use cookies or third-party trackers** for behavioral targeting or ads. If implemented in the future, users will be notified and consent will be requested.
