May the 4th be with you: Star Wars on Coinage

It is no surprise that the megaworld that is Star Wars has permeated many parts of our world and numismatics is no exception. Shown below are a few of the pieces that have been produced by the New Zealand Mint for worldwide distribution.



COIN COLLECTING FROM THE U.S. MINT

Native American \$1 Coin Program

In 2009, the U.S. Mint began minting and issuing \$1 coins as part of the Native American \$1 Coin Program. The coins feature designs celebrating the important contributions made by Indian tribes and individual Native Americans to the history and development of the United States. The program is authorized by the Native American \$1 Coin Act (Public Law 110-82).

The program builds on the Sacagawea Golden Dollar, released from 2000 to 2008. It featured a portrait of Sacagawea carrying her infant son, Jean-Baptiste on the obverse (heads side) and an eagle on the reverse (tails side). It was authorized under Public Law 105-124, also known as the United States \$1 Coin Act of 1997 (Section 4 of the 50 States Commemorative Coin Program Act).

Note: Native American \$1 coins are circulating quality produced as collectibles, not for everyday transactions. However, they may still be used as legal tender.

Design Requirements

The obverse (heads side) design retains the central figure of the "Sacagawea" design first produced in 2000 with the inscriptions LIBERTY and IN GOD WE TRUST.

The reverse (tails side) design changes each year to honor an important contribution of Indian tribes or individual Native Americans with the inscriptions \$1 and UNITED STATES OF AMERICA. Reverse designs for the Native American \$1 Coin are selected by the Secretary of the Treasury after consulting with the U.S. Senate Committee on Indian Affairs, the Congressional Native American Caucus of the U.S. House of Representatives, the Commission of Fine Arts and the National Congress of American Indians, and after public review by the Citizens Coinage Advisory Committee.

Like Presidential \$1 Coins, Native American \$1 Coins have a distinctive edge, are golden in color, and feature edge-lettering of the year, mint mark and E PLURIBUS UNUM.

During the years of the program that correspond with the Presidential \$1 Coin Program, Native American \$1 Coins will be issued, to the maximum extent practicable, in the chronological order in which the Native Americans depicted lived or the events recognized occurred. Following the conclusion of the Presidential \$1 Coin Program, the Native American \$1 Coin Program coins will be issued in any order determined to be appropriate by the Secretary of the Treasury after consultation with the U.S. Senate Committee on Indian Affairs, the Congressional Native American Caucus of the U.S. House of Representatives, the Commission of Fine Arts and the National Congress of American Indians, and after public review by the Citizens Coinage Advisory Committee.

The U.S. Mint's 2023 New Releases for May

Abraham Lincoln Presidential Silver Medal





Abraham Lincoln was an American lawyer, politician, and statesman who served as the 16th President of the United States from 1861 until his assassination in 1865.

The obverse (heads) of the medal features a portrait of Lincoln with the inscription "ABRAHAM LINCOLN" centered along the border. The reverse (tails) features a wreath of oak and laurel within a pearled ring with the inscription "INAUGURATED PRESIDENT OF THE UNITED STATES MARCH 4, 1861. SECOND TERM MARCH 4, 1865. ASSASSINATED APRIL 14, 1865." Within the wreath is a spray of pine and cedar, circled by a serpent with its tail in its mouth-the Egyptian symbol of eternity and immortality.

U.S. Coast Guard Bronze Medal





This is the bronze medal version of the U.S. Coast Guard Silver Medal issued through the Armed Forces Silver Medal Series. Honor Coast Guard veterans or your own service while recognizing the contributions of our military.

The obverse (heads side) design depicts a Coast Guard national security cutter at full throttle, speeding head-on toward the viewer. The inscriptions "U.S. COAST GUARD" and the Coast Guard motto "SEMPER PARATUS" (Always Ready) are arced around the upper border. The hull number identifies the cutter Hamilton, named for Alexander Hamilton.

The reverse (tails) design depicts two iconic symbols of the Coast Guard, a life preserver ring and the Coast Guard racing stripe mark, which is found on almost all Coast Guard craft. The racing stripes are depicted with a heraldic hatching tradition to indicate color. The horizontal lines indicate the color blue, while the vertical lines indicate the color red. The Coast Guard emblem, which is part of the racing stripe mark, is also in the center. Inscribed into the life preserver ring are the Coast Guard's core values "HONOR," "RESPECT," and "DEVOTION TO DUTY."


