Vendor Rules and Guidelines

Payment of Space, booth assignments, and cancellations:

- Payment in full must be made when the space reservation form is submitted. Make checks payable to "LPQG" or Livingston Piecemakers Quilt Guild. Form and payment should be mailed to:

- Reservations must be made by May 1, 2026
- Booth Assignments will be approved by June 1, 2026

Our Vendor space is limited. If applications exceed our space, we will notify you to see if you would like to be put on our waiting list. All payments will be refunded if we cannot provide booth space for you.

Booth Equipment and Services

- Single Booth is 10' x 10' and includes two (2) chairs
- Double Booth is 20' x 10' and includes two (2) chairs
- Electricity is available but you must request it on your application. You will need to supply your own tables, drapes, display racks, extension cords, tape to cover the cords, lights and any other equipment needed to meet your display needs.
- If available, we will have some black drapes to hang between vendors.

Exhibit Hours

- Exhibit Hours are from 10:00am – 5:00pm on Friday and 10:00am-4:00pm Saturday. The doors will open for you at 8:00am on both days.

Installation and Set-Up

- The Polk County Commerce Center will be open for Vendor Set-up on Wednesday 5pm-9pm, Thursday 4pm-6pm and Friday 8am-10am. Judging will happen on Thursday so if it is still in progress, we would ask you to be quiet at that time.

Restriction in the use of space:

- All business must be confined to the limits of your exhibit booth. No subletting or sharing of booths is allowed without prior approval of LPQG. Displays must not interfere with other Vendors. LPQG reserves the right to restrict exhibits which may detract from the general appearance of the show.

Special Exhibits:

- Scented items, i.e. Scentsy Candles, essential oils etc., are welcome but cannot be diffused due to possible allergens. Please be courteous to your neighbor vendors and attendees with any special exhibit.

Hospitality Room:

- LPQG will have a Hospitality Room for Members and Vendors. There will be Members who can cover you for a short period for lunch or restroom breaks if you are alone in your booth.

Dismantling and Take-down:

- The Vendor agrees not to dismantle the exhibit before the final closing out of the exhibit, which is Saturday, April 20, 2027 at 5:00PM.
- Goods must be removed from the exhibit hall as soon as possible after the close of show.
- Vendors must check out with the LPQG Chair prior to leaving the premises.

Cancellations:

In the event that due to an act of God or other unavoidable circumstances, the LPQG Quilt Show is either cancelled or show dates are changed and mutually agreeable dates cannot be arranged, a full refund of all payments will be made.

These regulations become part of the contract between the Vendor and LPQG. LPQG respectfully asks for the full cooperation of the Vendors. All points not covered here are subject to the decision of the LPQG.
