Executive Summary

Introduction

This document, the Colfax Township Parks & Recreation Master Plan, is intended to guide present and future recreational resource development within the township, including park land, park facilities, recreational programs, and public open spaces.

The purpose of this document is to serve as a guide in planning future recreation opportunities for Colfax Township. To be effective as a guidance tool, it must be kept current, considering population shifts, development of new projects, and changing attitudes towards leisure activities.

Short-term goals, such as maintenance issues and small recreation facility improvements can be implemented quite easily with minimal costs. Long-term expansions/construction will require additional study and involvement of residents to work out the site-specific details. This plan is simply the foundation for these activities to occur. The focus of the plan is to identify the desires of residents and attempt to satisfy the recreation needs of the entire community.

Meeting the goals in this plan or revisiting the priorities as conditions change and/or funding opportunities arise will help in grant solicitation from the Michigan Department of Natural Resources (MDNR).

Community Description

Location:

Colfax Township is located in Wexford County, within the northwest region of Lower Peninsula. Notable cities surrounding Colfax include Traverse City to the north, Cadillac to the south, and Manistee to the west.

Natural Features:

Soils:

Sandy soils are the main type found within Colfax Township. There are two types, Kalkaska Sand and Moncalm-Graycalm, that make up about 70% of the soil on their own. The other 30% is a mix of sandy loam, clay loam, and wetland soils.

Vegetation:

Much of Colfax Township is forested, consisting of a mix of hardwoods and pines. Second generation red pines are the most dominant species, with maples, hemlocks, and beech trees mixed in. A large portion of the Township overlaps with the Manistee National Forest boundaries and it even includes a few small patches of forested areas owned by the DNR. These areas are under some sort of resource/recreation management program through the federal and state governments.

Water Resources:

Colfax Township is located within the Big Manistee River watershed, which flows into Lake Michigan. The largest major lake, Dayhuff Lake, is a big recreational and tourism draw for the Township. There are no major rivers that run through the Township, just a few creeks that feed into the Manistee River. The largest being Silver Creek, which also offers excellent trout fishing opportunities.

Demographics:

When planning for the recreational needs, one of the most important components is to understand the demographics and the social make-up of the community. The Townships demographic data has been compared to Wexford County to provide a broader picture of the social characteristics. The information below was gathered using the 2020 United States Census Bureau, and it should also be noted that the Census data does account for people visiting or residing in the Township during the summer months.

Population: The Township's population has been steadily increasing over the past few decades. As the population increases, so will the need for recreational facilities for both residents and tourists.

Recreation Inventory

Barnes Memorial Park, also known as Colfax Township Park, is the Townships lone recreational facility located within its jurisdiction. The Township and their consultant, Prein & Newhof, conducted a tour of the park to evaluate its current condition and talk through possible future improvements. The following inventory (pages 9-10) includes a brief description of the park along with park type, size, and service area. The park has also been evaluated for accessibility using the accessibility assessment criteria set forth by the Michigan Department of Natural Resources.

Community Recreation Planning

The Township regularly hosts community events at Barnes Memorial Park for everyone to enjoy free of charge.

The local school systems are a large source of recreational activities provided to the Township, heavily directed towards school age children. Colfax Township is served by Mesick and Manton Consolidated Schools.

Grant Inventory

Colfax Township has not received any grants from the MDNR as of this time.

Planning Process

Public Input

Colfax Township values the opinions and views of its residents and helped develop the following process to gather the community's thoughts by:

- The consultant, Prein & Newhof, worked with Colfax Township over the course of several months via phone, email, Zoom, and face to face meetings.
- Making digital and hard copies of the survey available to all residents that asks specific questions of the current parks and their goals for the future.
- The Draft Plan was made available for public for 30 days to allow for public comment.
- Held a public hearing prior to adopting the park plan on 1/9/2024.

Survey Summary Results

The parks and recreation survey was available from July 21st to August 25th. The public notice for the survey was posted on the township website and the Barnes Memorial Park on-site bulletin board. There was a total of 46 responses to the survey. 46 responses were given online, while 0 were filled out by hand. The survey results show that 52% of residents support are in favor of expanding the parks system. 66% of people believe an improved park system would enhance their quality of life. A bulk of people taking the survey were between ages of 55-64 and prefer to be notified of future info through the Township website or Facebook. 36% of people responding have a child under 18 currently in their household.

27.3% of responders are not concerned with the park systems within Colfax Twp continuing to grow. Of the 72.7% that are concerned, the most reoccurring comments are:

- Unwanted consequences
- Possibility of tourists polluting
- Possible financial impact

The top 3 barriers making it difficult to visit local parks (including public comments):

- Lack of time
- No current barriers
- No parks or programs interest me

The top things residents **like** about the existing recreational facilities in the area:

- Natural setting
- Peaceful
- Clean and well maintained
- Close proximity to home

The top things residents **do not like** about the existing recreational facilities in the area:

- Facilities are dirty and not well maintained
- Negative impact on natural resource, milfoil in Dayhuff Lake
- Visitors not respecting park rules

Top 3 reasons why people visit parks and trails:

- Natural Setting
- Quiet/ Peaceful
- Close to home

Top 5 recreation opportunities

- Non-paved multi-purpose trails for non-motorized activities
- Playgrounds
- Picnic areas
- Paved multi-purpose trails
- Wildlife/ birdwatching platforms

Top 3 most needed recreational opportunities:

- Multi-use parks that serve the whole community
- Natural areas
- Trails/ pathway systems

Only 23.8% of responders believe there is a group of residents that would benefit from additional recreational opportunities. The comments given represent all age groups from children to seniors.

Goals and Objectives

The information received from the public survey was reviewed, calculated, and analyzed to identify the communities' goals and objectives. The Colfax Township residents who participated in the survey have provided valuable feedback regarding their wishes and desires for the recreational facilities and activities within the Township. The following goals and objectives were formulated based on the total number of surveys that were filled out.

Goal 1: Improve Barnes Memorial Park to provide recreational opportunities for all members of the Community.

Objectives:

- Improve the existing layout for the campground and park in a way that promotes safety and accessibility.
- Enhance the recreational opportunities through improved water access, site accessibility, and open green space.
- Improve facilities to include a mix of modern and rustic camping opportunities.

Goal 2: Improve the cleanliness of Barnes Memorial Park and Lake Dayhuff.

Objectives:

- Improve the parks cleanliness by constructing a new modern restroom building and camper waste stations.
- Add boat washing stations to prevent the spread of invasive aquatic species, such as Eurasian watermilfoil.

Goal 3: Look for opportunities to acquire more land in the Township for recreation while the property is still undeveloped, available, and affordable.

Objectives:

- Explore the possibility of expanding existing park facilities.
- Consider purchasing land within the Township boundaries to develop new parks or non-motorized paths.

Goal 4: Improve overall accessibility within all current and future Colfax Township parks facilities.

Objectives:

- Work with park professionals for the planning & designing future park projects.
- Consult with local disability groups to make sure future parks and programs meet accessibility standards.
- Renovate existing park features to be barrier free and more accessible when possible.

Action Program

Through the knowledge of the Township Board along with the input provided by the public survey it is apparent that the residents in Colfax Township value a clean, well maintained, and peaceful local parks system. According to the survey, the community is on the fence about any expansion of the park system. Knowing this, any future plans for park updates, improvements, or expansion will be shared with the community ahead of time to receive feedback and gauge community interest.

Communications

According to the survey results, the public prefer to receive updates through the Township's website and community Facebook page. The Township is planning to continue to improve all communication methods with a focus on digital means.

Park Development


According to the survey the largest public concern for expanding the park system is the creation of unwanted consequences (46.7%). As the Township moved forward with its goals to enhance Barnes Memorial Park, it will need to keep this in mind. The Townships objectives of improving accessibility, recreational features, camping facilities, and park cleanliness all align with the feedback received in the survey.

Environmental Stewardship

The survey shows people are concerned about invasive aquatic species entering Lake Dayhuff and the Township recognized that as a serious concern. To reduce the chances of allowing invasive aquatic species into Lake Dayhuff the Township believes constructing a boat wash area is a top priority.

Accessibility

The Township needs to address barrier-free accessibility throughout Barnes Memorial Park. Providing ADA access to our beaches, community space, and camping areas is of the utmost importance.
