



Onondaga County Department of Water Environment Protection (OCDWEP) has received the July 28, 2023 Notice regarding the proposed project for Micron New York Semiconductor Manufacturing. OCDWEP has no objection to the Onondaga County Industrial Development Agency (OCIDA) acting as lead agency for the purposes of SEQR.

OCDWEP is an interested agency in this project due to sewer service for both municipal and industrial wastewater disposal and a proposed reclaimed water supply service. The project will require the following approvals from OCDWEP:

- Capacity Assurance for new Sanitary Sewer Service
- Industrial Wastewater Discharge Permit
- Sewer User Agreement
- Plan Review and Plumbing Permit

Please note the following comments and clarifications related to the SEQR Long EAF, as included with the Notice:

1. **Section D.1d.iii.** – Change answer from “Yes” to “No.” The project is wholly located within the Onondaga County Consolidated Sanitary District and no expansion of the district is required.
2. **Section D.1d.iv.** – Change answer from “Yes” to “No.” No new districts are required.

We appreciate the opportunity to comment on the SEQRA documentation.
