#### Terms of Contract

Fifty percent (50%) of a stated stud fee shall be received as a deposit by stud owner (or their agent) before breeding. A nonrefundable service fee of \$425 shall be retained on all breedings employing fresh-chilled semen or frozen semen.

The bitch owner shall pay costs of transport of the stud dog for semen collection, semen collection fees and shipping fees for breedings employing fresh-chilled semen. Cost of transportation of the stud dog to semen collection site and veterinarian charges for collecting the stud dog and preparing and shipping fresh-chilled semen are determined per occurrence and paid by credit card/Paypal before collection and shipping of semen.

The remainder of the stud fee will be due upon confirmed ultrasound performed by a licensed veterinarian or date specified in this contract.

#### CONDITIONS STUD OWNER AGREES TO:

1. Provide bitch owner with a complete three generation pedigree of the dog.
2. Sign litter registration promptly and return to bitch owner.
3. Provide the bitch owner with a written receipt for the Collection Stud Service.

#### BITCH OWNER AGREES TO:

1. Pay the agreed stud service fee (50% prior to breeding) and, Remainder due at the time of a confirmed ultrasound performed by a licensed veterinarian or date specified above.
2. Provide a three generation pedigree before servicing.
3. Keep the bitch properly confined following the Artificial Insemination to ensure no other dog could mate her accidentally before mating season is finished.

4. Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any person or firm connected with the business of resale or wholesale of dogs.

OTHER CONDITIONS:

1. One puppy born alive or dead constitutes a litter.
2. If the bitch fails to conceive on this service, this contract is terminated and a new contract will be made of both parties agree.
3. The stud owner has no control of the semen collection after it leaves the veterinary office. Once the semen leaves the veterinary office the liability is transferred to the bitch owner/ agent solely.
4. Stud owner agrees to send a collection meeting standards. If collection is substandard stud owner will call bitch owner prior to shipment and confirm bitch owner wants collection sent still or would like a collection replacement within 24hrs shipped. After collection leaves veterinary office it is bitch owners responsibility solely.
