YMCA of the Suncoast

Joanna Castle and David Reed described the Academic Enrichment Program which is targeted at helping low-income or at-risk underperforming 1st grade children for early intervention in reading and math. The afterschool program is 3:30-5:30 two days a week and allows the students individualized and small group instruction.

At the end of the 2018 school year assessments indicated that 99% of the 139 students in the program made learning gains. This program has been in place for 3 years and data has shown to make a significant difference for these students.

United Way- Mission United

Amy Meek, CEO, and Tom O'Brien, Director, explained that Mission United is a national United Way program administered at the local level dedicated to helping local veterans in need and assisting with connecting them with resources and services to help alleviate various problems. Citrus County has the 2nd highest number of vets in Florida (per capita) and 70% are over the age of 65, so their needs are those of an aging population. Mission United is asking for a grant to fund their "Got Your Back Fund" which is a discretionary fund for help with housing, utilities, home repairs, shelter, furnishings, among other varied needs.

3. Approval of Minutes

Joan Plunkett moved that the Minutes of the December 3, 2018 meeting be approved as submitted. Susan Savard seconded the motion, which passed unanimously.

4. Treasurer's Report
