Mr. Sipper gave each of us 2 handouts, "The Path News" and Becoming Whole". He discussed the purchase of new acreage that will be used for farming and housing which is in demand. The Path had previously purchased dressers for housing, but now need more. Fathers have been given custody of their children and they need a place to store their things. The price of the dressers has doubled since the first time they were purchased. They have had a Capital Campaign that was successful. They have 40 clients that rotate jobs at the farm, and they recently hired a new Head of Cafeteria. She uses produce from the farm for many of the foods that she prepares.

Mr. Sipper answered the members' questions.

The Path is requesting \$10,000. for the purchase of new dressers.

Ms. Burdette presented information about the 4 programs that The Foundation has sipported in the past: Golden Citrus Scholars, Early Literacy Library, Teacher Mini-Grants and scholarships for the Marine Science Station. She discussed a successful Fun Run that raised money for the Educational Foundation.

MS. Burdette answered the members questions.

The Education Foundation is requesting \$16,000. to continue the 4 programs.
