#### 2. Presentations:

Stephen Hutchinson presented an update on the YMCA of Citrus County concerning their request for \$5,000 for the After School Program. The After School Program is provided in space leased from the school, so no transportation is required. It serves K-5th grade for 42 weeks. They have homework time as well as "Y Reads" and snacks. The Directors are all credentialed and all employees (part-time and full-time) are vetted.

DuWayne Sipper, who has been Director of The Path for 27 years, presented a request for \$10,000 for a security camera update, although this may not be the total cost of the project. This camera update is for their transitional housing. He also discussed the recent purchase of a 60 acre farm of which 20 acres will be for housing. They are currently serving 60 clients a day.

Travis Anderson presented his request for \$15,000 for the Boys and Girls Club Before School Program. This program costs \$85/month for 10 months. He also discussed the After School Program, and their Summer Program that includes field trips. Nursing home visits are included in the field trips and the students are excited to do these buying Christmas presents for the residents this year.

### 5. Old Business

The Black Diamond Foundation Board wants to be good stewards to the funds entrusted to them by our donors. In order to respect the wishes of donors who wish to direct their gifts to designated 501 (c)(3) charities in Citrus County, Florida, we will honor these directions without reservation. In addition, the Board will also budget, in 2025, undirected funds in 3 major categories. These are 1) Education 2) Food and 3) Housing. For our 2025 Budget, we designate \$50,000. for each of these categories, bringing our total undirected funds budget to \$150,000. Each year, the undirected funds budget will be adjusted for categories and amounts based on the donations received and expected to be received.
