# Community Food Bank

Ms. Lopell presented information about the needs of Citrus County; because of the two hurricanes Citrus County reported that there are 26,000 more people who are categorized as food insufficient.. They are now providing over 4.6 million pounds of food. The homeless are a small percentage, with a large percentage being seniors. The CCFB is associated with Feeding Tampa Bay and Feeding America. They are engaged with Healthy Eating research to spotlight foods to help prevent obesity, diabetes, high blood pressure, etc. They are also working on an Empowerment Center to help individuals and families. They have rescued 1.5 million pounds of "reclaimed" food, plus fruits and vegetables before they expire. They have fewer than 12 paid employees. The money we grant them will help pay down the mortgage.

### Citrus County Education Foundation

Ms. King presented the needs of the CCEF in four areas which would be mini-grants to include the First Library. These 4 mini-grant requests are for the same programs as in years past.

Josh White still evaluates the problems of students on a need-by-need basis. Their "Athlete's for Education" dinner was very successful.
