Ms. Evans gave each of us a "Planned Expenses" for the year 2024, and an overview of the AOL team and how it is managed. This information included the makeup of the team - 77% of the members are under the 200% poverty level, and 1/3 come from non-traditional households. There are no expenses for the parents, the Gate Fees are paid for them; most games are within a 2 hour drive of Lecanto. If an overnight stay is necessary, the AOL is a 501c3, so they receive a reduced rate at the hotel. There is no charge to be on the team, but members must try out, maintain a C+ average and the coach talks to the parents to be sure the baseball player is respectful at home. The Head Coach does not receive a salary.

She had a presentation on her computer and indicated that a donor's name can be shown during the live game coverage.

She is requesting \$5,000. for the Cooperstown Experience in Panama City, Florida.

She answered the Board Member's questions. Roger Obenauf thanked her for her presentation.

7. New Business

Mid-Florida Homeless Coalition submitted their report, but there are still questions about several of the line items. More accounting information needs to be clarified before they are invited to make a presentation.

There is no requirement to replace former Board Member Mary Jane Bower, however Roger will be talking to a new member of Black Diamond who is a philanthropist.

Citrus County Blessings has been relocated from the Community Food Bank. Foster Lamm will investigate their status and report back to the Foundation Board. They have requested making a presentation.
