Christina Reed presented information re: Blessings - it is currently purchasing food from Sysco. This is a more reliable source for receiving what they need. Peanut Butter is given to them free, they purchase the jelly. Currently, there are 13 items in the weekend bag. 98% of the food is purchased. The bags are distributed in public, private, preschools and homeschoolers. An ongoing program with middle schoolers and high schoolers is underway to determine what they would like and how best to distribute it. Backpacks are given for the weekend, extended breaks and to cover holidays. Questions were answered. They are requesting \$50,000.

Sonya McCaughey introduced Mary, the Clinic Manager. Ms. McCaughey said the clinic is in need of a new X-ray machine. The one they have is 30 years old and no longer HIPAA compliant. They also need a new compressor; the one they are using is 30 years old. They receive funding from the Homosassa Thrift Store, which provided the \$25,000. for a new AC unit.

They currently have 47 individuals waiting for appointments They have 5 dentists; the dentist needs a dental assistant and office manager when treating patients.
