I have included all the information that I could obtain. I hope my work proves satisfactory.

Introduction to Norfolk County

The first colonists in Virginia gave names of places and persons in England to rivers, crocks, counties and ports of ontry in the New World. Thus we have Norfolk, Portsmouth, Princess Anne, Isle of Wight, etc. The now territory was divided into eight shires and later called counties which were established in 1634. The eight original counties were James City, Warrick River (Warrick), Warrosquyoake (Isle of Wight), Charles River (York), Accawack, Henrico, Charles City, and Elizabeth Cith.

Elizabeth City county was formed by the Colony of Virginia in 1634 and comprised the present counties of Nansemond, Norfolk and Princess Anne. From this county the part lying on the South side of the James River was cut off and formed into New Norfolk county about 1636. About 1637 New Morfolk county was divided into Upper Norfolk county and Lower Norfolk county. Upper Norfolk county was then changed to Nansemond. Lover Norgolk county was in 1691 divided into Norfolk county and Princess Anne county. Norfolk county retained all the records of the older counties back to 1636. These records are now at the Chesapeake Civic Center, Great Bridge, Virginia. All the records were moved from the courthouse at Portsmouth, Va. to the Chesapeake Civic Center, Great Bridge in September 1962. The lower part of Norfolk county was called Chesapeake; North of Elizabeth River continues as the City of Norfolk and Princess Anne county was changed to Virginia Beach. There is no Norfolk county now.

The Diom Family in Norfolk County, Virginia

The Odom name id variously spelled Odeon, Odion, Odium, Odam, Odum, Odom. The Odom family is found in Norfolk county, Virginia as early as 1651. William Odeon, the Hariner of London and master of the good ship commonly called by name () bought 100 acres land on Elizabeth River from George Heigham.

He had a friend who could look after his affairs while he was on the high seas.

William Odeon was living on his land when he died Feb 1662. He died before his youngest son #66 Richard was seventeen years old. His will was dated 25 Jan. 1662, proved 16 Feb. 1662 Book D page 368 Norfolk Co. His children as in will were William II, Ellen, and Richard (see pages 5-6). His wife was not mentioned. Evidently she was deceased.

William II heired all the land from his father, besides one-third of the moveable property. His sister Ellen and brother Richard each received one-third of the moveable property. He bought and sold land in Norfolk county.

William Odeon II, son and heir of William I deceased, assigns rights of 100 acres land to Thomas Curle.

William Odeon II son and heir of William Odeon I, deceased assigns rights of land to Francis Sayer.

Joseph Whitson and wife Mary assigns rights to another piece of land to William Odeon II. Mary gives consent to sell the land, Deed Book 5 page 223 19 Dec. 1684 Norfolk Co.

From Lower Norfolk Co. Libraries-Vol. I p 121-no of books in library among them Mr. William Odeon II-three old books and a Bible. July 16, 1687

William Odeca II married and had two sons- John Odeon and William Odeon III. John bought land and settled in Mansembnd Co. where his fatheral's brother Richard was living.

From the Quit Rent Rolls of 1794 in Nansemond county
Richard Odeon ogned 50 acres
Jacob Oadham owned 20 acres

John Odium of County of Mensemoni sold his right of patent to land to Nicholas Stallings of Chowan precinct. Book w page 15 ' 19 Oct. 1700 Chowan Co.

Then John Odi.um bought 200 acres land from Charles Gaffin on West side of -----below Woodwards Creek (Later Gates Co. 1779)
Book W page 91 30 Sept 1706 Chowan Co.

John was a young man when he came into Chowan precedent (later Gates Co. 1779). He lived in what is now Cates county N.C. His son John Odium, Jr. bought 200 acres land at a pine in Keelan Branch etc. of Chowan precinct (later Gates Co.).

William Odcor III, John's brother, married Patience Warrick, daughter of Henry of Southern Branch of Elizabeth River. They continued to live in Norfolk county.

Henry Wirick (Warrick) of Southern Branch of Rlizabeth River gives by will to daughter Patience Odeon and son-in-law William Odeon.

Will dated 1710 Will Book 9 page 25 Norfolk Co.

Hary Warrick, widow of Henry Warick deceased gives possession of property to two children William Odeon and wife Patience and Mary Bartes.

Book 9 page 27 20 April 1711 Norfolk Co.

They had five children. His will was dated 29 Dec. 1743 proved 16 March 1744

Children: names as in will--- Patience Butt, Ann. Eary, Elizabeth and WilliamOdeon IV (see will pages 7-8-9-10)
Book H page 96 Norfolk County.

William Odeon IV followed other members of the Odem family into what is now Gates county, N.C. and settled there. His will is at Gatesville, Gates county proved 1794 (see will page 15-16)
