In 2019 the Elder Law and Disability Rights Center continued to serve seniors, people with disabilities, and their families. As the only sliding scale legal service organization in Orange County we are fighting to close the justice gap. And we continue to bring legal services to those vulnerable individuals who are unable to take advantage of the traditional options. In that role we served hundreds of homeless individuals with problems including from access to shelter, due process, trust disputes, tickets, and more. Our support saved lives. At the same time, we invested time and resources in community education to ensure that we could answer every call for education on the challenges that face our community experiencing homelessness and interfere with county wide solutions. Throughout 2019 we continued to serve seniors through our senior center legal clinic, advise, representation, and information. We kept one senior from losing her home and falling into homelessness when she found herself in a receivership without the tools to navigate the complicated process. Another adult with disabilities was able to stay in the assisted living home he came to love because we defended him when litigation was brought against him after an alleged altercation with another resident. And hundreds of seniors were given the comfort of having their end of life plans complete despite limited resources. As we enter 2020, we are excited to continue all these services and more.

3. Dissolution of the corporation requires a majority vote of directors not 2/3 of the directors. 4. In Section 7.1.1, the maximum number of directors was increased from 9 to 15 and the board is now allowed to fix the actual number of directors by resolution. 5. In Section 7.1.2, the following director qualification was added: "Directors must be licensed to practice law in California as long as it is required by Corporations Code Section 13406(b)(2)(B)" and the requirement that a director be 18 was eliminated. 6. In Section 7.4.2, directors may be removed from office (a) without cause by a majority of Directors then in office and (b) for cause by a majority of Directors present at a meeting where there is a quorum. Previously, directors could only be removed, with or without cause, by the vote of 3/4 of the members of the Board. 7. In Section 7.5, the requirement for a regular meeting of directors was changed from quarterly to annual. 8. In Section 7.6, Special Meetings of the Board can now be called by the Treasurer. 9. In Section 7.7.2, the notice by mail requirement was changed from 10 days to 4 days. 10. In Section 7.9.1, quorum was changed from "a majority of directors authorized" to "a majority of Directors then in office (but no fewer than two Directors or one-fifth of the authorized number)." 11. In Section 7.13, written consent can now be transmitted by first-class mail, messenger, courier, facsimile, e-mail or any other reasonable method satisfactory to the Chairperson or the President. 12. Emergency Bylaws were added in Section 7.16. 13. In Section 8.1, the board is permitted to delegate the authority to act on its behalf to a committee by a resolution by a majority of the directors in office. 14. In Section 10.2, the requirement that all reimbursements over \$500 be approved by the majority of non-interested directors was eliminated. 15. Indemnification of directors, officers, employees and agents was added in
