Food Security:

Supplemental Assistance and the Holidays by Nicole Grabner, Director, One Voice Brevard

In Florida, more than 2.8 million residents may face disruption to their SNAP benefits beginning November 1. SNAP, or the Supplemental Nutrition Assistance Program, is a federal program that provides monthly funds to low-income individuals and families to help them buy groceries. The Florida Department of Children and Families (DCF) warns that recipients may receive notices of eligibility but will not receive deposits to their EBT cards until federal funding is restored, as the federal government has been shut down for over 28 days at the time of the writing of this article.

For families with disabilities, the interruption poses an outsized risk: households often rely heavily on the consistent monthly benefit to cover nutritional needs, especially when additional care, medical costs, and transportation burdens are present. According to analysts, over 70 % of Florida's SNAP recipients are children, seniors, or persons with disabilities. In this context, a benefit pause means the stability of food access for vulnerable family members is dramatically weakened.

Thankfully, community food assistance channels stand ready to help fill gaps. State-wide network Feeding Florida collaborates with more than 2,400 partner agencies across all 67 counties and distributes hundreds of millions of pounds of food annually. Families looking to donate or pick up food items can connect with local food banks such as Second Harvest Food Bank of Central Florida, which offers pantries, mobile distributions and supports individuals including those with disabilities.

In these uncertain times, families facing food-insecurity (especially those caring for a member with a disability) should reach out proactively to local food banks and community agencies. At the same time, generous community members and businesses are encouraged to donate shelf-stable foods, hygiene supplies and monetary gifts to bolster local food systems. Together, these efforts can help buffer the blow of benefit interruptions until federal funding is restored.

Committee Week News

Every year, the Florida Legislature schedules “committee weeks” (sometimes called interim or interim committee weeks) in the lead-up to its regular legislative session. These weeks give members of both the Florida House of Representatives and the Florida Senate time to hold policy workshops, hear from state agencies and advocacy groups, review proposed bills, and prepare for the full session.

During these weeks, disability-related issues are increasingly on the agenda. Advocacy groups highlight bills such as HB 447 (Disability History & Awareness Instruction), which will require Florida schools to include more disability rights and history in the curriculum. Other key topics addressed include improvements at the Agency for Persons with Disabilities (APD) in Florida, maintenance of Medicaid eligibility for individuals with permanent disabilities, and equipment repair rights (e.g., power wheelchairs) for people with disabilities.

These committee weeks offer a critical window for families, self-advocates, and service providers to engage with legislators before bills become fully drafted. Because legislators are gathering expert testimony, reviewing agency reports, and holding workshops, it’s a prime time to raise concerns about issues such as waiting lists for services, accessibility of state systems, and funding for disability supports.

In short, committee weeks in Florida are a key pre-session period where policy-making momentum builds—and a meaningful time for the disability community to be heard. One Voice Brevard Scholarship Opportunity

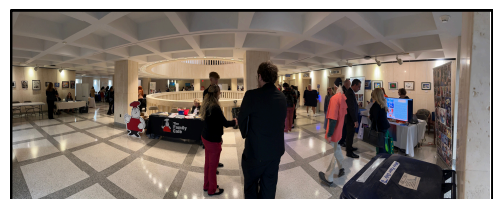
Families of individuals with developmental disabilities have a unique opportunity to make their voices heard at the state level. A new scholarship program from One Voice Brevard is offering financial assistance for two families of four to travel to Florida's capital, Tallahassee, to participate in Developmental Disability Awareness Day this February 2026.

Each year, advocates, families, and self-advocates gather at the Capitol to meet with legislators, share personal stories, and highlight the importance of supporting individuals with developmental disabilities across the state. This one-day event provides an empowering platform to influence policy, promote inclusion, and raise awareness about the needs and achievements of the disability community.

The scholarship aims to remove financial barriers that might prevent families from attending. It will cover travel expenses, lodging, and meals during the trip, up to \$300.00. Families selected will also receive guidance on how to effectively share their experiences and advocate for change.

Participation in Developmental Disability Awareness Day not only educates lawmakers but also strengthens the collective voice of the disability community. By attending, families help ensure that critical programs, services, and supports remain a legislative priority in Florida.

Applications for the scholarship will run from 1 November until 28 November, and families are encouraged to apply early as space is limited. (The scholarship application is on the next page. Please fill out and make sure to email to us once completed.) We will announce the winners on 1 December. Together, we can make a difference—one conversation at a time.

Nonspeakers's Bill of Rights

I am a nonspeaker with autism who types to communicate. In 2022, I founded Communication 4 ALL (C4A), a nonprofit with the mission to ensure all nonspeakers have access to communication and education. C4A has 3 strategic initiatives.

The first is C4A Academy, a program of internet based instructional videos to teach nonspeakers how to type, free of charge. C4A Academy also has case studies, written lessons, resources and support. If you know a nonspeaker who cannot communicate their thoughts and feelings to you, please tell their family about Communication 4 ALL's website of resources.

Our second initiative is Regulation 4 ALL. I believe most nonspeakers are so dysregulated that their bodies are in fight-or-flight mode. I presented my two-year experiment working with a researcher monitoring my heart rate variability (HRV) and using natural interventions to get me out of fight-or-flight to safe mode at the 2024 Medical Academy of Pediatric Special Needs conference. You can watch the presentation on our website. We just completed a study with Dr. Elizabeth Torres at Rutgers University measuring the HRV of 25 nonspeakers over 3 months. This study will serve as the foundation for creating tools to help nonspeakers get their bodies out of fight-or-flight. Follow Communication 4 ALL on social media to hear our announcements.

Our third initiative is C4A Schools. We work with schools, group homes and day programs to train their staff to create typing programs for nonspeakers. C4A Schools are beacons in the educational community, lighting the way for all schools to teach typing to nonspeakers. If you work with nonspeakers and want to discuss how you can give them a voice, please email me at elizabeth@communication4ALL.org.

Communication is a human right. Together, we can change the way the world understands nonspeaking autism. We have a motor disorder, not a cognitive one. Please call your state legislators and ask them to co-sponsor our Florida Communication Bill of Rights. This Bill ensures that individuals with disabilities can use their preferred method of communication to live happy, productive lives.

Connecting the Dots Conference

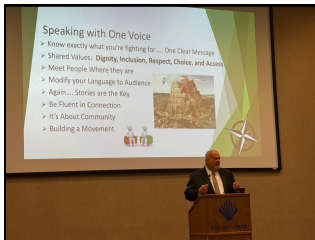

In 1993, the Florida Legislature created the Family Care Councils of Florida. Each council is comprised of families walking this path together and the individuals who motivate their participation.

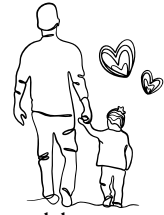

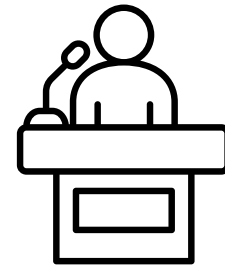

Bill Buzz

Lawmakers in Florida are already filing bills ahead of the upcoming 2026 Legislative Session, and for our community it is time to be alert and watch for what is filed.. According to reporting, both chambers of the Florida Legislature have begun posting new proposals—even several months before session starts.

The filing of bills is a crucial stage; it determines which issues will be formally considered, what the language will look like, and sets the timetable for amendments and advocacy. For families, self-advocates, and service providers connected to disability issues in Florida, being familiar with these filings means they can identify bills that could impact services, supports, funding, accessibility, and rights.

For example, knowing when a bill related to guardianship, supported decision-making, or state agency responsibilities is filed gives advocates time to reach out to sponsors, testify in committees, or mobilize community input. Even if a specific disability-related bill isn't yet filed, the fact that hundreds of bills are already in the queue means the disability community can proactively review bill lists (via the official bill tracker) and begin monitoring for any proposals that affect employment supports, Medicaid, education, or caregiving.

Watching the legislative process closely is essential because the decisions made in Tallahassee directly shape the programs, services, and protections that affect people with disabilities every day.

Once bills are filed, they can move quickly through committees, often with limited public attention. Staying informed ensures that advocates and families can respond before major changes are finalized—whether it's funding for disability services, updates to Medicaid, or new accessibility standards.

Engaging early allows the disability community to educate lawmakers, share real-world experiences, and influence outcomes that promote inclusion, independence, and equal opportunity for all Floridians with disabilities.





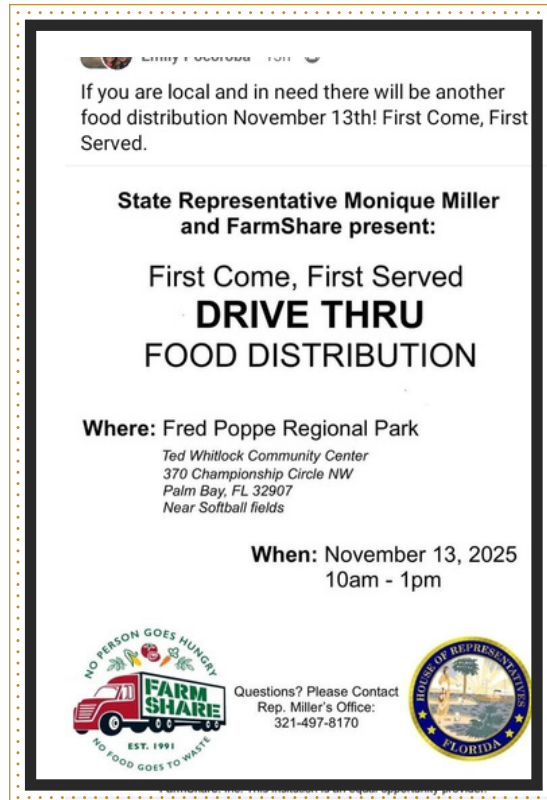
