- The plan length is for (1) year and no refund or credit will be issued if cancelled prior to expiration date.
- Coverage is for (1) residential heating system only. Separate plans can be purchased for additional units.
- This plan does not cover parts or labor required as a result of acts of God, fire damage, flooding, damage due to frozen pipes or water, fuel run-outs, failure to check water level of boiler, low water cut off, power failure, and flushing of the system.
- A&S Nathan reserves the right to inspect the heating system for eligibility prior to issuing or renewing the plan.
- A&S Nathan is not responsible for the discovery or removal of asbestos or other hazardous materials.
- Emergency Service is defined as an unsafe condition or condition causing damage to property. All other service will be performed during normal business hours.
- Payment is due at the completion of any and all appointments.
- A&S Nathan will not be liable for damages that occur due to negligence by the owner or owner's agent from not properly checking an occupied or unoccupied property.
- It is the homeowner's responsibility to renew their contract and to set up the tune-up appointment. A&S Nathan will not credit or prorate any tune-up not performed.
- A&S Nathan may void this contract at any time due to age, location, or overall condition of the heating system.
- There shall be no liability for any reason on the part of A&S Nathan for work done by another party. Any third party work done to the covered system may void this agreement.
- Payment confirms acceptance of this agreement and it's terms and conditions.
- If a scheduled appointment is missed, you will be subject to a \$85 (plus tax) trip charge.
