



WING COMMANDER “CALIFORNIA CIVIL AIR PATROL”

14 JANUARY 2026 SPEAKER

Col Craig Newton's career with the Civil Air Patrol (CAP) began in December 2011. He has held various leadership positions within the California Wing, including Group 7 Commander, Wing Inspector General, and Vice Wing Commander. Newton's qualifications include being a Mission Check Pilot Examiner (G1000) and (sUAS) pilot. He has also received the Gill Robb Wilson Award #3465, which is similar to the Spaatz award, indicating his high level of senior education within the CAP. Newton's aspirations as Wing Commander Select include learning more and teaching others, reflecting his commitment to continuous growth and education within the CAP.

CALIFORNIA WING of CIVIL AIR PATROL

California Wing of Civil Air Patrol (CAP) is the highest echelon of Civil Air Patrol in the state of California. California Wing headquarters are located in Van Nuys, California. California Wing consists of over 3,000 cadet and adult members at over 77 locations across the state of California.

California Wing performs the three missions of Civil Air Patrol: providing emergency services; offering cadet programs for youth; and providing aerospace education for both CAP members and the general public.

California Wing provides emergency services, including search and rescue missions, disaster relief missions, providing Air Force support, and assisting in counter-drug missions.

In March 2020, members of California Wing partnered with the American Red Cross to serve meals to children in the Los Angeles area while schools remained closed amid the COVID-19 pandemic.

Youth aged 12–18 may enter a CAP cadet program. At the age of 18, they may become a senior member or stay as a cadet. Cadets that decide to stay as a cadet may continue until they become 21. The cadet program provides a 16 step program covering aerospace education, leadership training, physical fitness and moral leadership. California Wing offers an annual summer encampment for cadets to further their skills.

Civil Air Patrol provides aerospace education for both volunteer CAP members and the general public. The internal education program for CAP members educates senior and cadet members; the external program for the general public is provided through workshops offered through the nation's education system.

California Wing is divided into eight groups across the state, with each squadron being assigned as a component of a group based on its geographical location. (Source: Wikipedia)

FLIGHT 30 BYLAWS AMMENDENT

In accordance with Flight 30 Bylaws, ARTICLE XIV. MISCELLANEOUS PROVISIONS,
Section 4. AMENDMENTS:

Proposed Bylaws amendments shall be submitted to the membership at least one month prior to the membership meeting at which an approval vote will be taken. These Bylaws shall be amended only upon a two-thirds vote of the members attending a regularly scheduled monthly meeting. Only amendments proposed by a majority of the Board of Directors or submitted to the Flight Captain over the signatures of at least ten percent of the members in good standing shall be placed before the Flight for a vote.

APPROVED FLIGHT 30 BYLAWS AMMENDMENT

The following Bylaws Amendment was approved by a majority of the Board of Directors at the 1 October 2025 board meeting:

ARTICLE XI COMMITTEES, Section 2. FINANCE COMMITTEE, Paragraph 9:

1. Remove the current Paragraph 9 which reads: “The Flight Treasurer serves as Chairperson of the Finance Committee for the management of the Scholarship and Life Member Funds, however, he/she may not conduct the Committee’s audit and/or direct fiduciary obligations without Board Approval”.
2. Replace with the following: ***“Financial Committee Oversite. The funds of the organization shall be managed under the oversight of not fewer than (3) Trustees. This structure is intended to ensure proper checks and balances, maintain transparency, and safeguard assets to the organization. No single Trustee shall have unilateral control over organizational funds. Financial decisions, including disbursements and transfers, must be approved by a majority of the Trustees in accordance with the organization’s fiduciary responsibilities and applicable law.”***

This December 2025 Newsletter is the one-month prior submission of the above Flight 30 Bylaws Amendment. The Flight 30 membership will vote on this Amendment at the 14 January 2026 scheduled meeting.
