 - a. Creation of QuickBooks

 - (a) Campbell also stated that he would get pods that go into the pool to keep it from being a home for mass amounts of mosquitos, and then require this committee to regularly drop them in the pool to dissolve.

Additional Notes From the meeting:

- The Pool pump valve has been fixed. The best course of action is to not pay to have the pool treated over the winter due to it being so far gone (in relation to cleanliness), and it would not be worth the cost of getting it back to clear for the winter months.
- Part of the lots were actually cut by the county, but that will not be a regular thing we
 can count on, so we now have a grounds guy, Craig, to take care of that. It will cost
 roughly \$1300 a month but was agreed that it is well worth it. Additionally, Melinda
 will try to track down getting the county/jail to take care of the ditch on the creek side
 of the pool.
- Going forward, the board would like to come up with a list of projects that would improve the pool. Also, create a bank account for members that would care to donate money outside of their membership dues to go towards the projects list.
