User or you	any third party that accesses the Website and is not either (i) employed by G&W Electrical Services Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to G&W Electrical Services Ltd and accessing the Website in connection with the provision of such services; and

- 2. In this Privacy Policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, schedules or appendices of this Privacy Policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this Privacy Policy.

## Scope of this Privacy Policy

- This Privacy Policy applies only to the actions of G&W Electrical Services Ltd and Users with respect to this Website. It does not extend

## Your Rights

If any court or competent authority finds that any provision of this Privacy Policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this Privacy Policy will not be affected.
- 23. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 24. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
