

# GREENVILLE SPORTSMENS CLUB

Membership for Greenville Sportsmen Club cost \$50.00 per year.

***(Save \$10 off annual membership if you join on day of class)***

That membership gives you the right to shoot on the rifle and pistol range and provides discount shooting for both skeet and trap.

For those who only shoot during fall to sight-in the hunting rifles we offer a Fall membership. This membership costs \$25.00 and is available for the period beginning September 1 and ending December 31st.

We have several rifle ranges available (200 yd, 100 yd, 75 yd and 50 yd). In addition, we have an outdoor pistol range available.

To use the pistol or rifle range you must be a member.

We have three skeet fields, 2 with Laporte trap machines and 1 field operating on Winchester/Western machines.

We also have a new trap field. The field is equipped with a new Pat trap capable of throwing both single and doubles trap. We have also installed a ventriloquist voice release system.

The pistol and rifle ranges are open from 10:00am until dusk 7 days a week.

The skeet and trap fields are open Wednesdays, Saturdays and Sundays from 10:00am until the last shooter leaves. The skeet and trap facilities are open to both members and nonmembers.

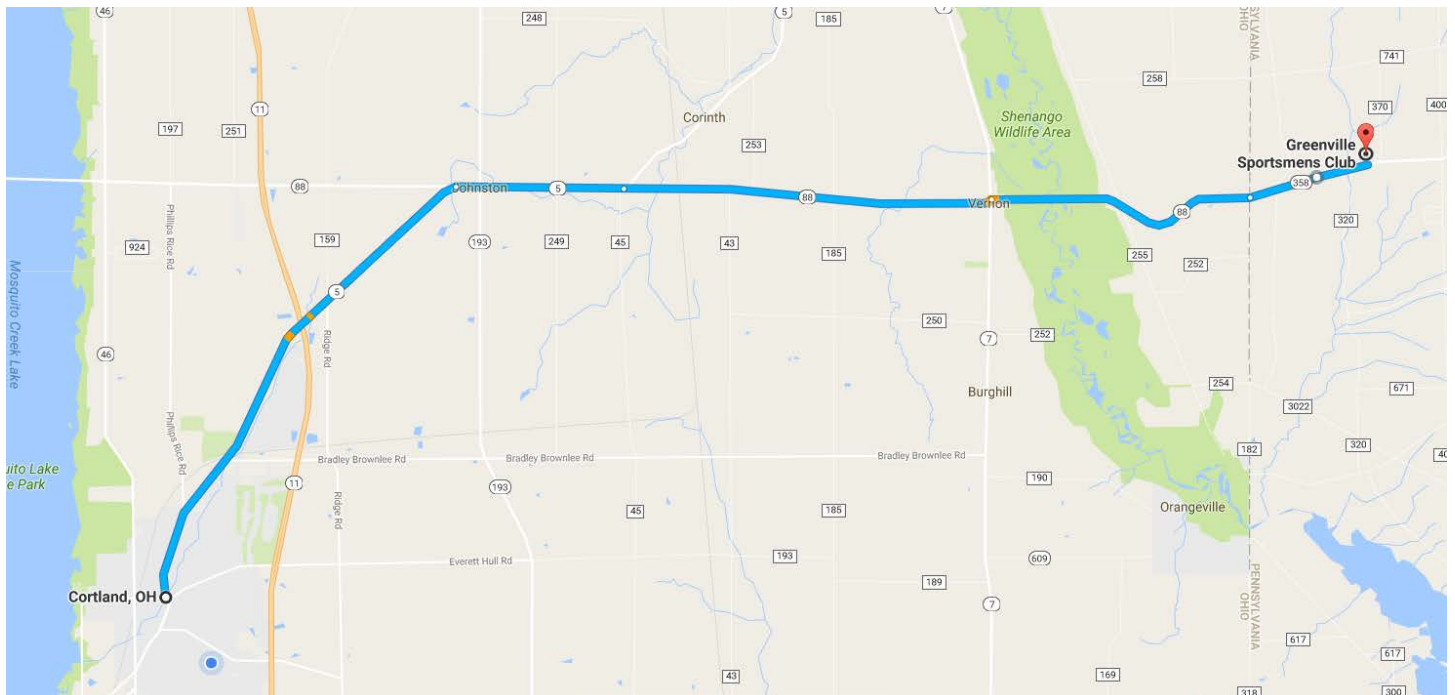
-Rte 11 North, Exit on OH 5/OH 88, Cortland/Jamestown, PA

The undersigned member shooter agrees to observe all Camp Rules and Regulations, including but not limited to the safe transportation, possession and use of firearms on the premises, all posted rules and procedures:

1. No loaded firearms shall be brought into the club house or onto the grounds. Legally Licensed CCW Permit Holders may carry as permitted by their CCW/CHL.
2. When carrying a firearm onto a shooting field the firearm is to remain unloaded with the action open until the shooter is on the shooting line or shooting station ready to shoot, and it is safe to discharge the firearm. Always keep your finger off the trigger until you are pointing the firearm in a safe direction and ready to fire. In the event of a misfire, or jamming of a firearm, do not attempt to clear the firearm until it is safe to do so, and in a manner which insures the safety of the shooter and other shooters in the field.
3. Adequate Eye and Hearing Protection must be worn at all times when on a shooting field.
4. Never point a firearm at anything other than an approved target with an appropriate backstop or background.
5. All Posted Rifle and Pistol Range Rules are to be followed.

### ASSUMPTION OF RISK / RELEASE / INDEMNIFICATION OF CLAIMS

Although the Club takes all necessary and reasonable precautions and steps to provide for the safety of all participants in the shooting sports, the use of firearms and recreation shooting is an ultra-hazardous activity for which the participant assumes the risk of personal injury and damage inherent in this activity. The undersigned is personally responsible for adhering to all camp rules, regulations and the safe handling and discharge of all firearms. Any minor and participant, with little or no experience in recreational shooting, must be strictly monitored and accompanied by an experienced shooter.

The undersigned acknowledges that I have read the above, and in consideration for using the Camp's Shooting Facilities, agree to all of the terms and conditions herein, and agree to be responsible for any and all damages to the Camp Facilities arising out of my conduct, acts or omissions, and I will indemnify and hold harmless the Greenville Camp, Mercer County Sportsman Association, its officers, directors, agents and employees against any and all claims, damages, loss and liability arising out of my intentional or negligent acts or omissions on the camp's premises. The Greenville Camp, Mercer County Sportsman Association is not responsible for lost or stolen property on the property. All persons shall take care and precaution to safeguard their possession and property while on the premise.

## **Rifle and Pistol Range Rules**

1. Shooting hours, 10 am until dusk - no shooting before 10 am or after dusk.
2. No automatic weapons to be used.
3. No rapid fire of semi-automatics.
4. The range will be closed from Good Friday thru the Easter weekend and Christmas day.
5. No random shooting. All shots are to be at posted targets on the target backers.
6. While shooting on the 200 yard range, no shots to be less than 100 yards. 25 yards and 50 yard shooting to be done on the shorter ranges.
7. The rifle and pistol range is for use by MEMBERS or SUPERVISED concealed carry applicants ONLY. Members must be 18 years of age, or have direct parental supervision.
8. The gate is to be closed and locked at all times, even while shooting.
9. Each member is responsible for cleaning his/her own targets and his/her debris that may have been brought to the range.
10. No alcoholic beverages permitted at the range.

Any member found in non-compliance to these rules will receive one warning. For any subsequent violation, the member will lose his/her membership.

The undersigned acknowledges that I have read the above Rifle and Pistol Range Rules and agree to abide by them at all times while utilizing Greenville Sportsmen Club facilities.
