LIABILITY RELEASE and ACKNOWLEDGEMENTS

SKEET AND TRAP RANGES ONLY

The undersigned NON-MEMBER/GUEST shooter agrees to observe all Camp Rules and Regulations, including but not limited to the safe transportation, possession and use of firearms and all posted rules and procedures while on the premises:

1. No loaded firearms shall be brought into the club house or onto the grounds. Valid CCW/CHL Permit/License holders may carry as the law allows as permitted by their CCW/CHL.
2. When carrying a firearm onto a shooting field the firearm is to remain unloaded with the action open until the shooter is on the shooting line or shooting station ready to shoot, and it is safe to discharge the firearm. Always keep your finger off the trigger until you are pointing the firearm in a safe direction and ready to fire. In the event of a misfire, or jamming of a firearm, do not attempt to clear the firearm until it is safe to do so, and in a manner which ensures the safety of the shooter and other shooters in the field.
3. Adequate Eye and Hearing Protection must be worn at all times when on a shooting field.
4. Never point a firearm at anything other than an approved target with an appropriate backstop or background.
5. All Posted Rifle - Pistol Range Rules are to be followed.

ASSUMPTION OF RISK / RELEASE / INDEMNIFICATION OF CLAIMS

Although GSC takes all necessary and reasonable precautions and steps to provide for the safety of all participants in the shooting sports, the use of firearms and recreational shooting is an ultra-hazardous activity for which the participant assumes the risk of personal injury and damage inherent in this activity. The undersigned is personally responsible for adhering to all Camp Rules, Regulations and the safe handling and discharge of all firearms. Any minor or participant of whom have little or no experience in recreational shooting, must be strictly supervised by an experienced shooter and club member.

The undersigned acknowledges that he/she has read the above, and in consideration for using the Camp's Shooting Facilities, agrees to all of the terms and conditions herein, and agree to be responsible for any and all damages to the Camp Facilities arising out of his/her conduct, acts or omissions, and that he/she will indemnify and hold harmless Greenville Camp Mercer County Sportsman Association, Inc., its officers, directors, agents and employees against any and all claims, damages, loss and liability arising out of his/her intentional or negligent acts or omissions on the Camp's premises. Greenville Camp Mercer County Sportsmen Association, Inc. is not responsible for lost or stolen property on the premises. All persons shall take care and precaution to safeguard their possessions and property while on the premises.

The undersigned also affirms and acknowledges the he/she is not prohibited under any Federal, State or Local law and/or any Court Order from possessing or handling firearms.
