Range Rules/Assumption of Risk

Although the Club takes all necessary and reasonable precautions and step to provide for the safety of all participants in the shooting sports, the participant assumes the risk of personal injury and damage inherent in this activity. Any minor and participant with little or no experience in recreational shooting shall be strictly monitored and accompanied by an experienced shooter.

RULES

1. Eye and Ear protection is REQUIRED on all ranges and fields.
2. **Hours of Operation:** All GSC ranges and fields are open Sunday through Saturday, 10am till dusk.
Skeet may be shot under the lights until 9:00pm only on designated night shoots.
3. The **ranges and clubhouse will be closed Good Friday thru Easter Sunday and Christmas Eve and Christmas Day.**
4. Follow the four basic steps to safe gun handling. Always point the gun in a safe direction. Always keep the gun unloaded and action open until ready to use. Always keep your finger off the trigger until ready to shoot. Always know your target and what is beyond.
5. In the event of a malfunction of a firearm make sure the "clearing" of the firearm is done in a safe manner to ensure the safety of others in the area.
6. Rifle and pistol ranges are for use by members **ONLY** (as described in GSC bylaws). **NON-MEMBERS** are not permitted.
7. No automatic weapons are to be used and no rapid fire of semi-automatic rifles.
8. Shooting doubles on clay target ranges is permitted.
9. While shooting on the rifle or pistol range use the DESIGNATED BACKSTOPS ONLY. No random shooting.
Utilize the 25 yard and the 50-yard ranges for shooting less than 75 yards.
10. The RIFLE range gate is to be unlocked and closed at all times while shooting. When leaving, close and LOCK the gate if no one else is on the grounds. (last one out)
11. Each member is responsible for removing their own targets and debris brought to the range including brass and empty shells
12. No shooter is permitted to shoot or resume shooting if he/she has consumed any amount of alcohol or a controlled substance. **No exceptions.**
13. No shooting at steel targets is permitted.
14. Dispose of any faulty ammo properly. Do not throw loaded ammo in the trash.

RANGE SPECIFIC RULES

10 Yard (Pistol) Range

1. Do not intentionally shoot at or attach targets to railroad tie border.
2. The 10-yard range is for pistol calibers and small firearms only. No centerfire rifle calibers permitted.
3. Targets are to be attached to the top horizontal wire using binder clips and/or clothespins. Members should bring their own supplies.

Clay Target Ranges (Skeet, Trap and Five Stand)

1. Shells shall not be placed in the shooter's gun until he/her is on station ready to shoot. Immediately after firing, the shooter shall remove the spent shells prior to leaving the station. If a delay occurs for any reason, the shooter on station shall unload his/her gun immediately.
2. No more than two shells may be loaded at any time. New shooters are encouraged to load one shell at a time.
3. Always be aware of your shot fall and what may be in the area.
4. All shooting to be done on designated stations.
5. No shot larger than 7 ½ to be used.
6. Any shooter under the age of 18 must be accompanied by an adult.
7. Members may bring nonmembers to shoot on the clay target ranges.

VIOLATION OF ANY OF THE ABOVE RULES OR MISUSE OF CLUB GROUNDS MAY RESULT IN LOSS OF MEMBERSHIP

The undersigned acknowledges that I have read the above, and in consideration of using the GSC's shooting facilities agree to all conditions and terms herein and agree to be responsible for all damages to the GSC facilities arising out of my conduct, acts, or omissions. I will indemnify and hold harmless the GSC and its' officers, directors, agents, and employees against all claims, damages, loss, and liability arising out of my intentional or negligent acts or omissions on the GSC premises. Greenville Camp, Mercer County Sportsmen Association is not responsible for lost or stolen property on the property. All persons shall take care and precaution to safeguard their possessions and property on the premises.

The undersigned also affirms and acknowledges that he/she is not prohibited under any federal, state, or local law and/or any court order from possessing or handling firearms, and that they have received a copy of this document.
