

ORDINANCE NO. 32

AN ORDINANCE OF THE TOWN OF BEVIL OAKS ADOPTING THE PROVISIONS OF CHAPTERS 1 THROUGH 10 OF TITLE 28, TEXAS REVISED CIVIL STATUTES ANNOTATED PROVIDING FOR THE TOWN OF BEVIL OAKS TO BE HEREINAFTER A GENERAL LAW CITY WITHIN THE STATE OF TEXAS AND PROVIDING FOR THE DESIGNATION OF WARDS AND THE ELECTION OF ALDERMEN TO THE GOVERNING BODY OF THE CITY OF BEVIL OAKS FROM SAID WARDS.

WHEREAS the Town of Bevil Oaks was duly incorporated under the provisions of Chapter 11, Title 28, Texas Revised Civil Statutes Annotated by an election duly called by the County Judge of Jefferson County, Texas on July 20, 1963;

WHEREAS the Town of Bevil Oaks has been operating as a Town under the provisions of Chapter 11, Title 28, Texas Revised Civil Statutes Annotated since the date of incorporation within the boundaries of the Town as hereinafter described;

WHEREAS the Town now has a population of 1,292 inhabitants; and

WHEREAS the Town of Bevil Oaks believes that it would derive benefit from operating as a General Law City under the provisions of Chapters 1-10, Title 28 of the Texas Revised Civil Statutes Annotated and has placed consideration of the adoption of Chapters 1-10, Title 28, Texas Revised Civil Statutes Annotated on the agenda of the regular meeting of the Board of Aldermen held October 21, 1980 and all other requirements of Article 961, Texas Revised Civil Statutes Annotated having been met;

NOW, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF BEVIL OAKS THAT:

1. The Town of Bevil Oaks shall hereinafter be referred to as the City of Bevil Oaks and the City of Bevil Oaks shall be operated as a General Law City pursuant to Chapters 1-10, Title 28, Texas Revised Civil Statutes Annotated.
2. The boundaries of the City of Bevil Oaks shall be the same boundaries as for the Town of Bevil Oaks and are particularly described by metes and bounds as follows:

BEGINNING at the intersection of the North line of State Highway 105 and the East line of the William C. Dyches Survey, and the West line of the J. Dyches Survey;

THENCE North 0 deg. 29 min. East to the South bank of Pine Island Bayou;

THENCE West and South along and following the meanders of Pine Island Bayou to its intersection with the North line of State Highway 105;

THENCE East along said North line of said State Highway 105 to the PLACE OF BEGINNING.

3. The City of Bevil Oaks shall be divided into three (3) wards and two aldermen shall be elected from each ward pursuant to Chapter 2, Title 28, Texas Revised Civil Statutes Annotated.
4. The boundaries of the wards and the designation of each ward are shown on the plat attached hereto and are particularly described by metes and bounds on the descriptions attached hereto.
5. Recording with Office of County Clerk. This Ordinance shall be signed by the Mayor of the City of Bevil Oaks, attested by the City Clerk or Secretary and shall be filed in the office of the County Clerk of Jefferson County, Texas.
6. Effective Date. This Ordinance shall be read at the regular meeting of the Board of Aldermen of the Town of Bevil Oaks held on October 21, 1980 and shall become effective on the date of passage.

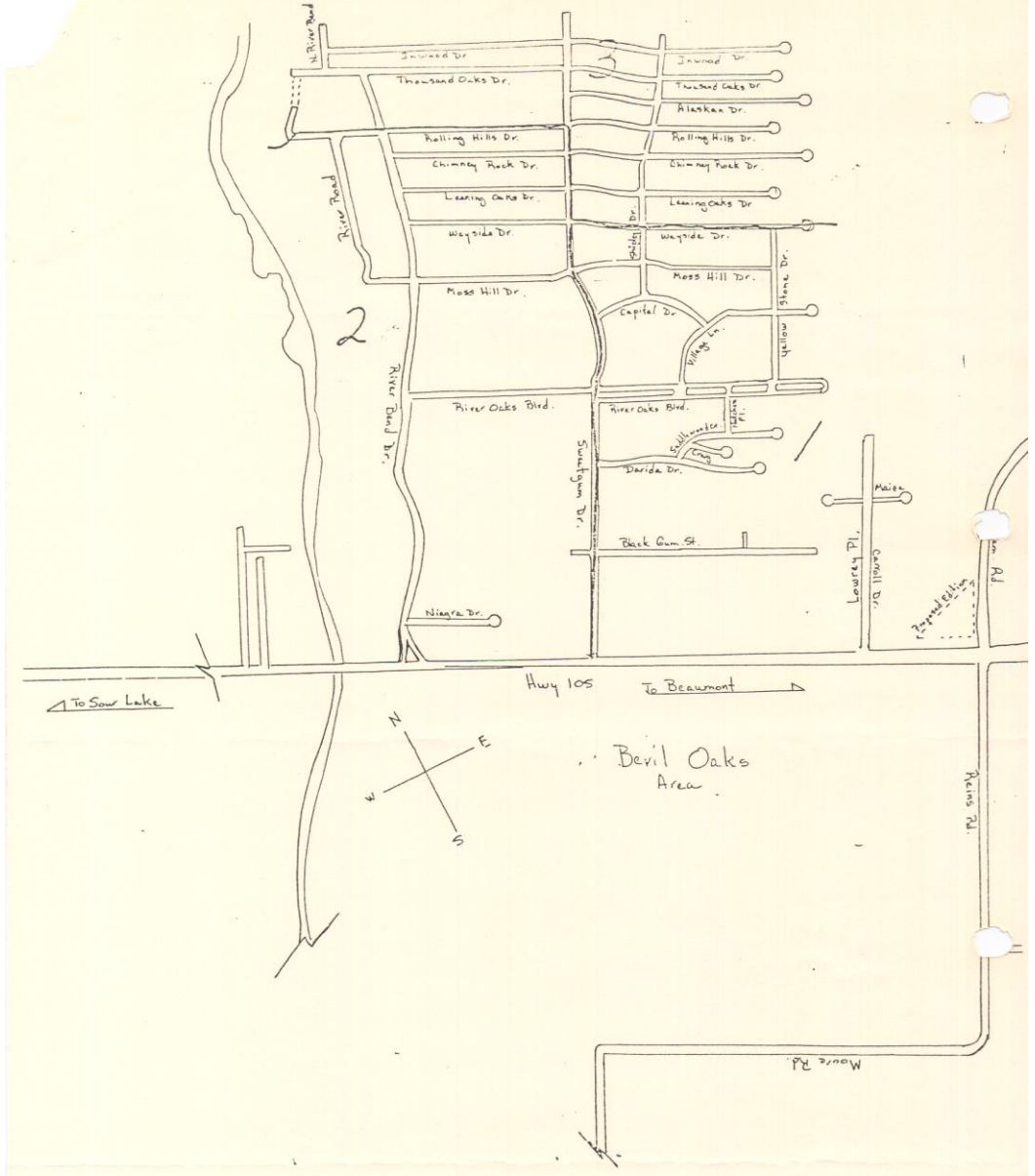
