EARLY VOTING for May 8, 2010 **BOMUD Board of Directors** election will be held on Wednesday, April 28 and Thursday, April 29, 2010 from 7:00 a.m. to 7:00 p.m. at the Bevil Oaks Civic Center.

Your vote "counts" in Bevil Oaks elections. Be sure to exercise your right to have your voice heard.

CITY COUNCIL NEWS: Terms of council members in each of the three wards expire in May. Due to there being no opposition for any of the three places, the City will not hold an election this year. The following unopposed candidates for council positions in Wards I, II, and III will be sworn in for two-year terms at Council's regular meeting, May 18, 2010. They are:

- Cathy Crane, Ward I;
- Don Smith, Ward II;
- Sherry Adams, Ward III.

Council wishes to thank Councilwoman, Michelle Nelson, Ward II for her four years of dedicated service to our community. Michelle has been a very active participant in organizing the annual garage sales, July 4th activities, newsletter publishing, and our previous 5K events. She has been a pleasure to work with on council and will certainly be missed by all. We wish her and her family the very best and look forward to continue working with her, as a citizen volunteer, on future community projects.

At Council's next regular meeting, Tuesday, April 20, 2010 a **public hearing** will be held for the purpose of allowing citizens to comment on the merits of Ordinance 204 that enforces a curfew in Bevil Oaks. Regulations require that curfew ordinances be reviewed every three years to allow for revisions, if necessary, and/or to discontinue the curfew entirely. Citizens are encouraged to attend this meeting and voice their opinions on the matter.

(BOMUD) NEWS: Positions 2 and 4 on the BOMUD Board of Directors also expire in May. George Bryant, position 2, ran unopposed for his seat and will begin a new four-year term in May. BOMUD's next regular meeting will be Tuesday April 13, 2010. A possible action item for the board could be whether or not to accept funding of the \$440,000.00 loan that was recently approved by the Texas Water Board. These funds, if accepted, will go toward the engineering portion of the new sewer plant project that is ongoing.

Last November, I worked to defeat the 3.4 million dollar bond election and began to search for a less costly approach for the new sewer plant that is needed. Zane Bledsoe and I formed the Greater BOMUD Sewer System Committee which now includes the following members: Ed Milam, Norman Lowrey, Danny Fruge, E. J. Booker and Joe Penner. The Committee began visiting plants in both Texas and Louisiana to view their systems with an eye to see which type would best suit our needs; be the most efficient; and, at an affordable cost. We have presented the BOMUD Board with our findings in hopes that they will see that there are many options available to us and, at a more affordable cost.

I realize that our sewer system is in need of replacement to insure the health and well-being of our community. It is my commitment to the people of Bevil Oaks to find a viable solution to this problem; to assure that our citizens are fully aware of the process; and, if elected, to assure that citizen concerns are heard on this board.

I relish your vote for BOMUD Director, Position 4, on May 8, 2010, place #2 on the ballot.



My name is George Bryant and I have served on the Bevil Oaks Municipal Utilities District Board of Directors for the past 9 years.
