## *Have You Received a Letter from Homeserve?*

Have you received a letter from a company called Homeserve? Several residents have informed us they are receiving information from companies about their water service line. The letter is stating the resident is not covered with Water Service Line Coverage from them.

We wanted to inform all citizens that this is NOT a City sponsored project. This is an insurance company soliciting your business. Before entering into an agreement with this or any other company, we recommend that you check their credentials with the Texas Insurance Commission, the Better Business Bureau, and any other source that is available.

## *Update on Sewer Agreement with the City of Beaumont*

At Council's regular meeting on December 19, 2013, Council approved an agreement with the City of Beaumont that allows Bevil Oaks to dispose of its waste water into the sewage collection system of the City of Beaumont. This agreement will now be presented to the Beaumont City Council for their approval. Once it has been approved, the City of Bevil Oaks will proceed with obtaining easements and other preliminary projects required to move forward with construction of this project. Citizens will continue to be updated as the project progresses.
