Law Enforcement in Bevil Oaks



Hopefully you noticed, in recent weeks, the increased presence of Jefferson County Sheriff's Department Patrol Units in our community patrolling our streets as well as working traffic. When the City had to eliminate the Marshal's department, we began working with "then" Chief Deputy Zena Stephens to set up a small sub-station, of sorts, in Bevil Oaks to allow officers a place to do paperwork, take a break, etc. and,

be more visible in our community to help offset, as much as possible, the loss of the Marshal's department. We almost had this worked out when Chief Stephens left the Sheriff's Department for her position at Prairie View. Once she became our Sheriff, we immediately approached her about this project that had never developed. She was receptive and units were immediately in Bevil Oaks under the supervision of Lt. Trish Molfino of the newly created Traffic Control Division. Officers have access to the civic center and the conference room is in the process of being set up for their use when they are in our area. Sheriff Stephens has hired ten (10) new officers and they are currently in training. Once their training is completed and the department is fully staffed, the goal is to have an officer in our office periodically and for longer periods than just for a break.

Sheriff Stephens, Captain Troy Tucker and Lt. Trish Molfino were all present at the community meeting held on February 7. At that time, they all stressed that it was important to them that they get to know our citizens and develop a good working relationship with the community. So, if you see that they are in the office, it is O. K. to stop in; introduce yourself; make them feel welcome; or, ask a question. They are here to help us make Bevil Oaks a safer place for all of us.

At this meeting, citizens discussed things we, as citizens, can do to make Bevil Oaks a safer place. They are:

- 1) SLOW DOWN! Speed limit on all streets is 30 m.p.h. Drive at 30 m.p.h. or lower
- 2) STOP AT STOP SIGNS! Do not just slow down and roll on through.
- 3) Actually stop and then proceed.
- 4) ENCOURAGE our neighbors to drive within the speed limit and

- 5) BE AWARE of what is going on in the neighborhood and on our street and report suspicious activities to the Sheriff's department

Please remember, officers do not have access to the various Facebook pages in Bevil Oaks. So, please do not just chat on Facebook about any suspicious activity. Please call the Sheriff's department prior to posting on social media so it can at least be investigated.

We now have in place a system to better protect and serve our community. Let's all work together to make this a successful endeavor and Bevil Oaks a safer place for all of us.

How Do I Read My Water Bill?

The first thing to look at on your bill is this area here. It lets you know the dates of the readings used for the bill, as well as the readings. On this bill, the readings were taken from Feb. 2 to March 6., and you can see they have two meters. The first meter, used 2,332 gallons of water, while the second meter didn't have any usage at all. If you look just below that, You will see their prior balance was \$79.34, and they made that payment. HOWEVER, some do not make a payment until after bills are printed, therefore pay attention to this section to see if your payment is listed. There is the \$23.50 user fee listed, which is on everyone's bill. Then to figure up the rate, both water and sewer costs are the same. Both are billed at a rate of \$0.006 per gallon. So, as you see above, the usage was 2332. Multiply that times 0.006, and you will get the \$13.99 billed for water and sewer. Here, you will also notice the water has an added \$3.00. That is added to anyone's bill who has a secondary meter. It covers the cost we pay for the software to read the meters and other such items each month. Had there been usage on that secondary meter, they would have been billed at the same rate of \$0.006 per gallon. The only exception is a secondary meter is not charged for sewer.

REMEMBER, ALL bills are due on the 21st, unless it falls on a weekend, then it is due the following Monday. If not paid on or before then, a \$15 late charge will be applied. You will see that charge on the next months bill, even if you have paid it to show you it was billed. But it will be in the payments as well.

Do You Have Dirty Water?

Do you have dirty water? Often times there is a simple explanation or reason behind it, and an even easier fix. If you see your water looks dirty at any time, please don't hesitate to call the office at (409) 753-2126. The phone numbers are always listed on the newsletters and on the outside of City Hall on the building. If it is after hours, the after hours callout number is (409) 753-7377. However, please note that if it is after hours, it will not be checked out until the next day. The after hours number is primarily for emergencies only, and customers do run the risk of being charged for calling the after hours number for such things as turning their water on/off or other items that is either the customer's responsibility or can be done during normal business hours.
