



# What's Going On Behind City Hall?

Many have called to find out why the trees behind City Hall have been cut down. As many of you know, the City was awarded a grant last summer by Texas Parks and Wildlife to purchase and install playground equipment and create a park on city owned property. This park is to be built close to the drainage ditch that runs behind City Hall and west of the Fire Station to Riverbend Road and on to Pine Island Bayou. This ditch is an eye sore and has not been maintained by DD6, because, as it turns out, DD6 did not have an easement for this ditch.

During the planning of the proposed park and walking trails, the City realized that this ditch was a posing a problem, not only for the park project but, for the drainage project where it crosses River Bend. When the request to DD6 was made, they agreed to improve this ditch if the following conditions were met:

- 1) First, they needed easements to the three tracts of land that borders this ditch. Those three tracts include BISD property, City property and a private tract at the western end of the ditch before it goes under Riverbend Road.
- 2) They would perform all work necessary to widen and improve this ditch and the City would have to pay for all materials needed to complete this project.
- 3) DD6 would provide a logger to remove the trees from the three tracts of land. The City was advised by DD6 that there was not enough timber on the city tract of land as to be commercially viable, but that they thought between the three tracts the logger could make enough so as not to charge DD6 for the removal of the trees.
- 4) The City would be responsible for disposing of all limbs and tree debris left over from the logging operation.
- 5) The City would be responsible for providing a place to dispose of the excess dirt that was generated from the widening of this ditch as well as spreading same if necessary.
- 6) In addition to the ditch widening, DD6 also agreed to replace the one 36" culvert under Riverbend with two 48" culverts. Again, the City is responsible for purchasing the materials both for the culvert installation as well as all materials required to patch the road when complete. The City decided to make this portion of the work Phase Two and complete this work in the next budget cycle due to monetary constraints.
- 7) DD6 will seed the 90' R.O.W when construction is complete and maintain this ditch going forward.

So, during budget talks last July, the City Council approved by a vote of 5 to 1 to authorize DD6 to move forward with this project and provided the estimated \$45,000 needed as the City's contribution in its 2016/2017 budget; DD6 has estimated their cost at just over \$200,000. In this budgeted amount, there were monies for procuring easements from both BISD as well as the private land owner. As it turned out, DD6 could procure an easement from BISD for no charge and the City recently procured the easement from the private land

owner at no charge since they were recently approved for a FEMA Buy out Grant for Repetitive Losses due to flooding. So, the city may or may not end up with some surplus budgeted funds depending upon how the project goes.

From a logical and construction stand point, the crossing on Riverbend (**Phase Two**) should have been completed prior to the ditch widening portion of the project (**Phase One**), however, two reasons complicated this approach.

- 1. Not enough money available in the 2016/2017 budget to fund both Phase One & Two during the same budget cycle. Phase One needs to be completed to take advantage of the grant funds before they expire. It did not make sense to construct a park adjacent to a large excavation project before that project is completed. Who would allow their children to play in such proximity to a construction project utilizing heavy equipment; creating tons of dust; and, having to use the same entrance for access as where the parking will be located for the park?
- 2. A sewer line that runs thru the middle of the 36" culvert on River Bend is to be replaced with two 48" diameter culverts. This sewer line only serves the one house that was recently included in the FEMA buyout. By postponing Phase Two until the City was sure the grant funds were approved for the FEMA Buyout, the City saved several thousand dollars that would have been needed reroute or otherwise remedy this sewer line interference that is no longer necessary since the FEMA Buyout funds were approved. The City will now be able to simply take this portion of line out of service.

It should also be pointed out that all these decisions had to be made last fall to authorize DD6 to perform this work so they could place this project on their work schedule which they make out in January of each year.

The contractor for DD6 has recently completed the logging operation. On June 2, DD6 moved a large track hoe with a "thumb" attached onsite to start piling the brush and debris to be burned and disposed of by the City. Unfortunately, all the rainy weather we have just experienced will set this operation back a bit. While we cannot get a specific time frame from DD6 as to when they will start this work, they have said they intend to have it completed by the end of summer. That's the best we have now.

For DD6, this is a drainage project that is long overdue to improve the drainage for a sizable portion of the central part of Bevil Oaks. For Bevil Oaks, not only do we receive the benefit of better drainage, but also an improvement to our property ahead of our playground and park development. In addition to the playground equipment and covered picnic area to be provided in this grant we have already been awarded, the City also has long range plans of creating "Hike & Bike" trails on this property as well. A request was submitted for a grant to install Phase One of the Hike & Bike trails but, we were informed last week by the State that we did not get picked because they had three times the number of applicants as they had money to award. We will submit another application this December if this program is still available.

So, the answer to the opening question is---progress!
