# **MOWING CONTRACT**

Sealed bids addressed to the City of Bevil Oaks, TX, City Representative for Grounds, will be received until 2:00PM on April 9, 2019 for mowing of the City Right of Ways and other areas as described in the specifications within the city limits of Bevil Oaks, TX.

Bids will be received at City Hall located at 13560 River Oaks Boulevard in Bevil Oaks until <u>2:00 pm</u> on <u>April 9, 2019</u> at which time they will be read aloud. Interested bidders will be furnished a bid tabulation upon request at a later date.

The contract documents, including the specifications, are on file, and may be viewed online at www.cityofbevioloaks.com. They can be downloaded or a complete bid package can be obtained at City Hall. A formal pre-bid conference will not be held. It is the responsibility of each bidder to contact and make arrangements for a site visit by contacting Danny Fruge, the current City Representative for Grounds, or the Mayor, at 409.753.2126 prior to the bid date. **A SITE VISIT IS MANDATORY AND IS A PREREQUISITE TO A BIDDER BEING AWARDED THE BID.** 

Each bid must include a copy of the contractors General Liability Insurance Certificate (a sample certificate indicating coverage for the bid will be adequate for bidding purposes) in an amount no less than \$1,000,000 and must name the City of Bevil Oaks, TX as Certificate Holder. It must also include a 30 day notice of cancellation. In addition, each bidder must have a Workers Compensation Policy. Before a contract can be entered into with the successful bidder, an insurance certificate indicating the required coverages must be provide to the city. In accordance with Texas State Law, including Local Government Code Chapter 176, each **BIDDER MUST COMPLETE AND SUBMIT WITH THEIR BID A COPY OF THE VENDOR'S CONFLICT OF INTEREST QUESTIONAIRE SHOWN IN EXHIBIT "A". NOTE to BIDDERS:** In item #1, the term *"Local Government Entity"* refers to the City of Bevil Oaks. If you answer NONE to this question, then all you need do is sign and date the form. Otherwise, you must fill out as instructed. In addition, a sample contract has been included for your review.

Eligibility of bidders is restricted in accordance with **Resolution #2018-0830** Titled <u>Resolution on Officials and Employees Doing Business with the City of Bevil</u> <u>Oaks</u> passed August 30, 2018. A copy of that resolution is included in this packet for your review. **A Bidders Check List** has been included for your convenience as well.

The right is reserved by the City, and its interest may require, to accept or reject any and all bids, and to waive any formality in the bids received. In case of ambiguity or lack of clearness in stating the price in any BID, the City reserves the right to consider the most advantageous BID thereof or reject the BID.

# **2019 Mowing Specifications**

### **BASE BID REQUIREMENTS- BID ITEM 1**

In general, mow from the edge of the street up to the tree line or the fence line of the right of way including trash removal and weed eating around sign post and culverts along the areas being cut. Mow the grounds at the civic center and LaRousse Park (item#12), fire station (#14), gutted out city hall building located at 7525 Sweetgum Rd (#14), around the basketball court as well as around the temporary city hall and to the west around the new playground (item # 14) currently being cut at this time. Mow up to the very edge of the DD6 ditch that runs along the edge of the property from the old gutted out city hall all the way over to River Bend Drive. In steep or deep ditches, it is not required to weed eat same. At this time, no weed killer is to be used without the written consent or direction from the City Representative for Grounds or the Mayor.

It is anticipated that mowing will begin around the middle of April. Based on a schedule of cutting every two weeks up until mid-November, mowing would occur about 17 times, more or less depending on weather. This is not to be considered a guarantee of times to be cut but rather an indication of the amount of possible cuts. During periods of heavy rain or extreme drought conditions, it may be necessary to delay mowing causing the number of cuts to be less. The Chairman of the Roads & Drainage will determine whether to delay cutting or, if heavy growth should occur, to increase the mowing frequency as well as decide when to end the mowing season. Once a date has been determined to end the mowing season, the Chairman will also decide when the mowing season will start the following year. The term of this contract will be for three years. If for any reason either party decides to terminate this contract, a 30 day notice must be given in writing stating so. Also, if at any time during this contract, the contractor allows his insurance to lapse or fails to provide proof of insurance, this contract will be terminated as soon as the City becomes aware that coverage has lapsed or been canceled.

At all times the contractor is to remain in the public right-of –way and to take all reasonable precautions against entry on to private property. No directions below are meant to indicate otherwise.

#### SPECIFIED STREETS ARE: (SEE HIGHLIGHTED AND NUMBERED MAP)

**River Bend Dr.: (1)** Starting at Hwy 105 and going North, mow the triangular area on the south east side of the street. **(2)** Then, starting at the right-of-way of Hwy 105, mow up to the tree line along the west side of the street all the way to the south property line of the house located on the south side of the pipeline ROW at River Oaks Blvd. **(3)** Move north and resume cutting

from the DD6 drainage ditch on the west side of Riverbend north to the property at the corner of Mosshill & Riverbend. (4) Then, mow north on the east side of River Bend from the property line of 7140 River Bend along the undeveloped area to the first house on pilings. (5) Then back to HWY 105, starting at the northeast corner of River Bend and River Oaks Blvd, mow north to the corner of Mosshill and River Bend.

**River Oaks Blvd: (6)** Starting at the intersection of River oaks Blvd & River Bend Dr, mow up to the tree line on the north side of the Blvd. east to the intersection with Sweetgum drive. **(7)** Then, continuing east on the grassy area between the two streets to the DD6 ditch that runs north/south. **(8)** Starting at Sweetgum and going west to the intersection with River Bend Dr, mow the grassy area on top of the pipeline ROW from the edge of River Oaks Blvd to the property lines on the south side of the ROW. Continue across River Bend westward and cut inside the U-shaped drive around the pipeline ROW but not all the way to the end at the chain link fence line farther to the west.

**Sweet Gum: (9)** Starting at Hwy 105 going north on the west side of Sweetgum, mow up to the shrubbery or fence line from the highway to the north east corner of the old trailer park. **(10)** Then, back to Hwy 105 on the east side of Sweetgum, mow the corner from the highway to the old bulletin board metal frame (currently holds banner regarding Hawk Country) continuing north to the end of the chain-link fence at the end of the first piece of private property. Back to the intersection of 105 & Sweetgum, mow the ditch along 105 in front of the corner property up to where the driveway was removed going east.

(11) On the east side of Sweetgum from the northwest corner of 7140 Sweetgum, mow up to ditch to the intersection of Blackgum-turn east on Blackgum and mow along the vacant lot to the ditch at the end of the wooded area.

(12) At the old Civic Center located at 7390 Sweetgum, mow from the street to the park fence line and all around the park as well as the Civic Center. Weed flower beds by the fence and fertilize and weedeat around the building and trees, etc.

**(13) Davida:** Mow up to the tree line in front of the undeveloped lot starting at the back property line of the corner property at 13345 Davida east the distance of the wooded lot.

(14) Sweetgum/River Oaks Blvd: Mow the area that is bounded by the DD6 ditch to the north, Sweetgum to the east, River Oaks Blvd. to the south and River Bend Dr. to the west. Included in this area is the old gutted out City Hall, the basketball court, the fire station, the temporary city hall mobile office and the new park to the west of the city hall, then westward to the wooded area and then around the corner between the wooded area and the DD6 ditch. Weed the flower beds and trim or shape the plants in the beds around the fire station and edge and weedeat around the buildings. (The old City Hall building will not be in use again. Therefore removal of the flower beds are to be done during the first cut.)

(15) Staring at the intersection of Capital & Sweetgum on the west side of Sweetgum, mow the undeveloped or wooded area north to the corner property at Mosshill and Sweetgum.

(16) Sweetgum: On the west side of Sweetgum at the intersection of Alaskan Dr, mow all of the property inside the fenced area as well as the outside of the fence around the Water Plant. Behind the fenced area are two small fenced enclosures; weed eat inside of these areas also.

(17) On the west side of Sweetgum just north of the intersection with Thousand Oaks, mow the area in front of the wooded property (undeveloped area).

(18) Shipley: Starting at the gate to the old sewer plant on the west side of Shipley, mow south in front of the wooded area. Then starting at the gate going north, mow both sides of the road up to the tree line all the way to the fence of the old sewer plant. (19) Cut inside the yellow highlighted area of the old sewer plant but <u>DO NOT CUT</u> the area highlighted in green around the top of the pond. The fence lines around the old sewer plant a well as around the pond are to be sprayed with weed poison 3 times per season about 12" inside and outside of the fence line. This is the <u>ONLY</u> area at this time that can be sprayed with weed poison.

(19) Inwood: Mow up to the tree line from the southeast property line of 13330 Inwood east around the cul-de-sac and down the south side of Inwood west to the east property line of 13325 Inwood. Weedeat the fence line at the end of the cul-de-sac.

(20) River Road: From the corner of Mosshill and River Road on the west side of River Road, cut up to the tree line along the wooded area to the first property just north of the DD6 ditch (7765 River Road). (21) Starting at the north property line of 7740 River Road on the east side, mow going north in front of the wooded area to the DD6 ditch and then continuing north to the north property line of 7750 River Road.

**LIFT STATION ENCLOSURES: #22, 23, 24.** Mow inside and weedeat fence line of 3 sewer lift station fenced enclosures located at the west end of Rolling Hills, the east end of River Oaks Blvd and on the west side of River Bend Dr. about a quarter mile south of the intersection with River Oaks Blvd.

Items #1 thru #23 described above will be the basis of the <u>BASE BID- BID ITEM 1</u> located on the bid sheet.

## **BID ITEM #2**

Currently, we have 4 FEMA Buyout properties that we would like to have cut on a once a month basis. These properties are: 7135 River Bend Dr, 7530 River Bend Dr, 7725 River Bend Dr, and 7750 River Road. If there are areas of these properties that are too wet to cut when they are mowed, then please plan on weed eating the wet areas in lieu of cutting with a mower. The only property that this is *likely* to occur at is 7725 River Bend Dr. Please bid each address separately in case the need should arise to cut less that all 4 at one time.

# BID ITEM #3

(25) Mow the area highlighted in green around the **TOP** of the pond or holding basin. **DO NOT** include mowing the banks or the slopes of the pond in this price. This area will be cut on an "as needed" basis at the direction of the City Representative for Grounds or the Mayor. The frequency will depend on weather related factors and will be cut on a 6 to 8 week interval.

# BID ITEM #4

Mow the banks or the slope of the pond (#25) at the direction of the City Representative for Grounds or the Mayor. This will be cut approximately 2 to 3 times per season, as determined by the City.

City will not be responsible for Contractor's failure to perform or furnish the Work in accordance with the Contract

Documents.

The City shall be the sole judge as to whether the performance of the Contractor is satisfactory or whether the environmental conditions affecting the City's property require termination.

No assignment of this agreement or any duties or obligation or performance hereunder shall be made in whole or in part by the Contractor without the prior written consent of the City.
