

ORDINANCE # 227

AN ORDINANCE OF THE CITY OF BEVIL OAKS, TEXAS ABOLISHING THE BEVIL OAKS MUNICIPAL UTILITY DISTRICT LOCATED WHOLLY WITHIN THE CITY OF BEVIL OAKS, JEFFERSON COUNTY, TEXAS AND

WHEREAS, the City Council of the City of Bevil Oaks, Jefferson County, Texas has evaluated the current services furnished and functions performed by Bevil Oaks Municipal Utility District (“B.O.M.U.D.”);

WHEREAS, B.O.M.U.D. is in the process of considering the propriety of incurring substantial indebtedness on behalf of the citizens City of Bevil Oaks and of B.O.M.U.D.;

WHEREAS, the City Council of the City of Bevil Oaks has investigated and determined that it would be advantageous and beneficial to the citizens of the City to undertake the services furnished and functions performed by B.O.M.U.D.;

WHEREAS, the City Council of the City of Bevil Oaks has investigated and determined that the City is able to undertake the services furnished and functions performed by B.O.M.U.D.;

WHEREAS, the City Council of the City of Bevil Oaks has determined that the most efficient and cost-effective method of providing services furnished and functions performed by B.O.M.U.D. is to abolish B.O.M.U.D. prior to the issuance of or agreement to incur any indebtedness, prior to the issuance of bonds of any type, prior to the use of grant funds or any other type of permissible loan or contract;

NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEVIL OAKS, TEXAS:

Section 1. Findings

- The Council finds that:
 - ▶ the Bevil Oaks Municipal Utility District (“B.O.M.U.D.”) was created from an area that, at the time of B.O.M.U.D.’s creation, was located wholly within the municipal boundaries of the City of Bevil Oaks;
 - ▶ the services furnished and functions performed by B.O.M.U.D. can be furnished and performed by the City of Bevil Oaks;
 - ▶ the abolition of B.O.M.U.D. is in the best interests of the residents and property in the City of Bevil Oaks and B.O.M.U.D.;

Section 2. Assets and Liabilities

- Upon abolition B.O.M.U.D., the City of Bevil Oaks will assume all of the assets and liabilities of B.O.M.U.D.;

Section 3. Basis


- The City of Bevil Oaks abolishes the District in accordance with Local Government Code Section 43.074

PASSED (based on a vote of two-thirds of the entire membership of the City Council of Bevil Oaks) AND APPROVED AND EFFECTIVE FROM this 15th day of June, 2010.
