

CITY COUNCIL APPOINTMENT PROCESS AND PROCEDURE

- 1. As applications are received, they will be forwarded to the Mayor and Councilmembers at the end of each workday.
- 2. Applicants may contact individual Councilmembers to discuss their candidacy for the vacant City Council position.
- 3. There will be no interviews with the City Council as a whole; all interviews will be at the discretion of the individual candidate and individual Councilmember.
- 4. Tentatively, the appointment to fill the vacant Council seat is scheduled to be voted on at the June 18, 2020 City Council meeting (Subject to change).
- 5. The appointed Councilmember will take oath of office and assume position at the next regularly scheduled meeting after appointment is made.
- 6. Council Seat, for Ward 1 is up for re-election on November 2021.

Citizens interested in being considered for appointment to fill the vacancy for **Ward 1** of the Bevil Oaks City Council may utilize this form or download the form at <u>https://cityofbeviloaks.com/</u>. Applications for the City Council position will be accepted daily from May 27, 2020 – June 12, 2020 at 5 PM. As provided in the Texas Election Code, each applicant:

- must be a citizen of the United States;
- must be at least eighteen (18) years of age;
- must have resided in the state of Texas for one (1) year;
- must have resided in the Ward at issue for six (6) months;
- must be a registered voter in the Ward at issue;
- must not be employed by the City;
- must not have been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; and
- must not have been finally convicted of a felony (unless pardoned or otherwise released from the resulting disabilities).

Resumes are requested but not required.

All information provided to the City is subject to the Open Records Act / Texas Public Information Act. If appointed, the applicant may elect to have home address, home telephone number and family member information excluded from disclosure requirements.

The City prohibits discrimination on the basis of race, color, creed, religion, national origin, sex, sexual orientation, marital status, disability, or age in all aspects of the City's personnel policies, practices and operation.

The position involves one regular meeting each month, typically held on the third Thursday of every month. Special meetings are called as needed. A Councilperson will be appointed to serve on other boards, committees and task forces.
