## **Hot Shots Competitive All-Star Financial Contract 2020-21**

**\*IMPORTANT:** If your family has specific arrangements dictating payment responsibilities between parents, please be sure this contract is signed by the legal guardian responsible for submitting payment for their child(s) participation in the Hot Shots All Star Program for 2020-21.

### PAYMENT OPTIONS:

- 1) Pay in full by May 25 using cash or check (no cards) to receive a 5% discount for your 11-month season of All Stars.
- 2) Select a \*12-month payment plan for your 11-month season of All Stars. Parent/guardian agrees to place an active card on file for auto debit on the first of each month starting from June 2020-May 2021. The total cost of the program is broken up into 12 monthly payments for the convenience of our families.

### DISCOUNTS OFFERED

- 5% discount if season is paid in full by May 25, 2020
- Sibling Discounts: Additional siblings receive a \$20/discount per month on payment plans, or a \$250 discount if season is paid in full
- Submit your contract by May 15, 2020 to receive a \$25 account credit PLUS a \$10 monthly discount on each plan
- See info packet for other available discounts

### ADDING LATE

Any participant who adds later than June 1 (date of first monthly payment) will still be responsible for a total of 12 monthly payments or the equivalent cost of an entire 11-month season. There is no "discount" for starting the program later in the season.

### YEARLY GYM FEE:

As of Jan. 1, 2019, all active accounts will be billed a required "yearly gym fee" of \$35 per family and will be billed to the account once a year as long as the student is active. This is a separate fee and is not included in the All-Star contract.

**\*IMPORTANT:** If you choose the 12-month payment plan, Hot Shots will divide the cost of our 11-month, 2020-21 program (June-April) into 12 equal payments (June-May). We do this to make the program as accessible as possible to our awesome families. As a reminder, should you choose to leave the program early, or should your child be removed from the program, you will still be responsible for completing all 12 payments for the season. Should an event producer choose to cancel one of our scheduled events, and we are unable to reschedule a comparable event, we will refund the published competition fee to our All-Star families.



Pay your 20-21 season in full by May 25 (check or cash ONLY) at a 5% discount off total amount due (not available via debit/credit card). There are NO DISCOUNTS ON APPAREL outside the "one and done" package.
