# School Budget Basics



#### What is a school budget?

A school budget is a school district's annual financial plan. It is an expression in dollars of how a district's anticipated revenues are allocated to its educational programs, co-curricular and extra-curricular offerings, and operations. A district's school budget has a direct effect on the quality of a child's education and school experience. In New York State, public school budgets are highly regulated and mandated by state law.



# Why should I participate in the school budget process?

Active community participation helps to identify what our community values in our public schools and ensures discussion about how limited resources will be spent. Participation also provides you with a better understanding of the issues affecting our public schools and their impact on programs for the upcoming school year.



#### How do I get school budget information?

The school budget is presented at public Budget Work Sessions of the Board of Education (the Board). All meetings begin at 8:15 p.m. at Garden City High School. Budget Work Sessions, unlike other Board Work Sessions, allow a period for public comment at the end.



## What if I can't attend the Budget Work Sessions?

The district posts Budget Work Session presentations on its website following the meeting. Visit gardencity.k12.ny.us and click Budget Information, then Budget Presentations. The Budget Presentations page also includes Budget Definitions, Budget FYIs, and other important information. ## What is this year's school budget timetable?

The Superintendent presents the district's proposed detailed budget to the Board and the community at the first four Budget Work Sessions. The Superintendent's proposed budget is the starting point for discussion. The Board and the community may comment and voice concerns during the Budget Work Session process. The Board may make adjustments before its acceptance and final adoption of the budget.
