Land Use, Off-Street Parking and Off-Street Loading Requirements

Character The Character's Meaning

- "p" This means that the land use shown at the far left of the involved row is a permitted principal use in the involved column's zoning district. As such, the use may be set up on a lot in the involved district so that it is neither subordinate nor incidental to another use on the same lot. Unless the Table specifically states otherwise, the establishment and existence of a permitted principal use are subject only to the zoning officer's grant of a zoning permit and an occupancy permit, both of which are to be given on the basis of whether or not the use, its buildings, and its lot comply with the applicable regulations of this Chapter (see §27-114, "Zoning Permits" and §115, "Occupancy Permits").
- "a" This means that the land use shown at the far left of the involved row is a permitted accessory use in the involved column's zoning district. As such, the use may be set up on a lot in the involved district so that it is subordinate and incidental to another use on the same lot. Unless the table specifically states otherwise, the establishment and existence of a permitted accessory use are subject only to the zoning officer's grant of a zoning permit and an occupancy permit, both of which are to be given on the basis of whether or not the use, its buildings, and its lot comply with the applicable regulations of this Chapter (see §27-114, "Zoning Permits" and §27-115, "Occupancy Permits").
- "t" This means that the land use shown at the far left of the involved row is a temporary use in the involved column's zoning district. As such, the use may be temporarily set up on a lot in the involved district subject to the requirements and regulations of Part 4, "Temporary Uses."
- "s" This means that the land use shown at the far left of the involved row is a special exception use (i.e., a "special exception") in the involved column's zoning district. As such, the use may be set up on a lot in the involved district subject to the approval of the Zoning Hearing Board under the procedures and conditions given in Part 3, "Special Exceptions and Conditional Uses."
