45	2/12/1897	Grant of franchise to Citizens Water Company to construct and maintain water pipes or mains in or under the several streets, lanes and alleys of the Borough of Philipsburg.
61	9/10/1903	Grant of franchise to Moshannon Light and Power Company to construct and maintain a system of poles, wires and cables upon, over, through or under the several streets, lanes and alleys of said Borough for the purpose of furnishing electricity for light and power to the inhabitants thereof.
68	1/19/1912	Grant of franchise to the New Steam Company to construct, erect, maintain and replace lines of pipes, mains and lateral and all necessary fixtures in relation thereto for the operation and conveyance of steam for heating purposes in, under and upon the several streets, avenues, lanes and alleys of the Borough of Philipsburg.
69	3/20/1912	Grant of franchise to the Philipsburg Electric Light, Gas, Power and Heating Company to construct, erect, maintain and replace lines of poles, wire, conduits and fixtures for the operation of electric light and power service in, over, upon or under the several streets, avenues, lanes and alleys of the said Borough.
119	8/13/1927	Grant of franchise to the Bell Telephone Company of Pennsylvania to construct, maintain and operate its posts, poles, cables, wires and all other necessary overhead apparatus on, over and along and its conduits, ducts, mains, pipes, cables, wire, manholes, terminal and distributing poles and all other necessary underground appliances on, in, under and through the streets, alleys and highways within the limits of the Borough.

907	9//6/1983	Grant of franchise to the Tele-Media Company to construct, establish, acquire, operate and maintain transmission and distribution facilities including, but not limited to, the erection of poles, cables, wires and other appurtenances and additions thereto in, under, over, along, across and upon the streets, lanes, alleys, avenues, sidewalks, bridges, tunnels, highways, parking lots and other public places in the Borough for the purpose of transmission by cable and distribution of television impulses and television impulses and television energy for sale to the inhabitants of the Borough.
