38	11/22/1894	To provide for a continuation of the general system of sewerage within the Borough of Philipsburg. (This authorized construction on Alder Street, Center Street, Eleventh Street, Fourth Street extension, Laurel Street, Locust Street, Ninth Street, Pine Street, Presqueisle Street, Tenth Street.
189	12/16/1933	Authorizing purchase of approximately 2,250 feet of sewer pipe at a cost of approximately \$2,500.
R.376	10/20/1955	Authorizing agreement between the Borough of Philipsburg and the Philipsburg-Osceola Area School District relating to the construction, operation and maintenance of a connecting sewer line between property of the School District and sewer collection system of the Borough of Philipsburg.
418	8/5/1958	Assessing two-thirds of the cost of the construction of a sanitary sewer on Sheffield Street in the Curtis Park addition to the Borough of Philipsburg.
419	8/5/1958	Providing for the construction of a sanitary sewer on Philips Street in the Curtis Park addition to the Borough of Philipsburg and providing for the assessment of a portion of the cost thereof against the property owners abutting thereon by the front-foot rule. (Construction was to begin 112 feet east of the Berkley Street-Philips Street intersection and proceed eastwardly 150 feet)
432	1/6/1959	Assessing against the abutting property two-thirds of the cost of constructing a sanitary sewer on Philips Street in the Curtis Park addition to the Borough of Philipsburg. (The construction was to begin 125 feet east of the eastern line of Berkley Street and continue eastwardly 187.5 feet)
536	6/16/1964	Assessing two-thirds of the cost of construction of a sanitary sewer on Hampton Street in the Curtis Park addition to the Borough of Philipsburg. (The 310 feet of construction involved the property of David B. Millward, 100 feet and the Church of the Nazarene, 210 feet)
538	7/8/1964	Assessing two-thirds of the cost of construction of a sanitary sewer on Hampton Street in the Curtis Park addition of the Borough of Philipsburg. (The 200 feet of construction involved the property of Owen W. and Dorothy Curtis)

541	9/15/1964	Assessing two-thirds of the cost of construction of a sanitary sewer on Sheffield Street in the Curtis Park addition of the Borough of Philipsburg. (The 150 feet of construction involved the properties of Pedro C.D. Martatez, 100 feet and Owen W. and Dorothy Curtis, 50 feet)
R.598	10/6/1966	On the planning requirements of Act 537, Sewage Facilities Act. (The Council agreed to cooperate in the preparation of County wide sewerage system plan)
710	10/7/1969	Assessing two-thirds of the cost of construction of a sanitary sewer in the Borough of Phillipsburg. (The 225 feet of construction on Hillcrest Street involved the property of Rembrandt L. Jackson)
R.712	12/9/1969	For engineering services relative to sewerage. (This authorized an agreement with Glace and Glace, Inc.)
R.725	1/4/1971	Indicating acceptance, submission and implementation of an official plan for sewage facilities in the Borough of Philipsburg, Pennsylvania. (The plan was submitted to the Pennsylvania Department of Health in compliance with the Pennsylvania Sewage Facilities Act of 1966)
757	5/4/1972	Assessing two-thirds of the cost of the construction of a sanitary sewer in the Borough of Philipsburg. (This refers to work on 13th Street)
821	9/25/1975	Authorizing and approving a service agreement, dated as of September 1, 1975, between Moshannon Valley Joint Sewer Authority on the one hand and the Borough of Philipsburg and the Township of Rush, both located in Centre County, Pennsylvania, on the other hand, under which said Authority will provide sewage treatment and disposal service for said Boroughs and for said Township, authorizing and directing execution, acknowledgment and delivery of said service agreement in behalf of this Borough and authorizing and directing other necessary and proper action.
847	7/12/1976	Assessing two-thirds of the cost of the construction of a sanitary sewer in the Borough of Philipsburg. (This refers to construction at 503 Philips Street)
