APPENDIX

ORDINANCE NO. _002 -- 2022

AN ORDINANCE OF THE BOROUGH OF PHILIPSBURG, CENTRE COUNTY, PENNSYLVANIA, APPROVING A PETITION FOR ANNEXING TO THE BOROUGH OF PHILIPSBURG A PORTION OF RUSH TOWNSHIP CONSISTING OF A PORTION OF A SINGLE TAX PARCEL OWNED BY THE BOROUGH OF PHILIPSBURG AND USED FOR PUBLIC PARK PURPOSES KNOWN AS THE COLD STREAM DAM RECREATION AREA, AND PROVIDING THAT THE SAID TERRITORY SHALL BE ANNEXED INTO AND BECOME PART OF THE BOROUGH OF PHILIPSBURG IF THE ANNEXATION THEREOF SHALL BE APPROVED BY THE COURT

WHEREAS, the Borough Council of the Borough of Philipsburg has received a Petition seeking the annexation of a parcel of land that lies partially in the Borough of Philipsburg and partially in Rush Township; and

WHEREAS, the Petition was signed by 100% of the landowners of the subject parcel; and

WHEREAS, the Petition has attached to it a certification confirming that a copy of the Petition was submitted to the Rush Township Supervisors in advance of the Petition being submitted to the Borough of Philipsburg; and

WHEREAS, the Borough Council of the Borough of Philipsburg does find it appropriate to annex the property as described in the Petition;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Philipsburg Borough Council, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: The Borough of Philipsburg hereby approves the Petition to the Borough, as such Petition was filed by a majority of the owners of the subject property proposed to be annexed to the Borough, being the parcel known as Centre County Tax Parcel 05-009-200, partially located in Philipsburg Borough and partially located in Rush Township.

SECTION 2: The Borough Solicitor, Manager, Secretary, and any other appropriate officers hereby are authorized and directed to take whatever steps are necessary to carry out the effects of the Petition, including but not limited to any action in the Courts of Centre County, and the proper officers are authorized and directed to carry out this matter to its conclusion.

SECTION 3: If the annexation of the said property is affirmed by the Court, the said property will be admitted, annexed to, and added to the Borough of Philipsburg, and shall, upon compliance with the legal requirements, be subject to the jurisdiction of the authorities of the Borough.

SECTION 4: Any Ordinance or parts of Ordinances of the Borough of Philipsburg, Centre County Pennsylvania, conflicting with this Ordinance or any part thereof is hereby repealed insofar as the same affects this Ordinance.
