# For the 2023 session, LCA is asking state policymakers to:

- Fund Mental Health & Substance Abuse Programs: Our Washington state government must address behavioral workforce shortage by expanding access to peer services by creating professional peer specialists. The state should approve new licensing requirements for certain Behavioral Health positions to increase workforce. We need to streamline the process to address the workforce issues in WA state to help support the crisis by providing specific training requirements, certification, and oversight.
- Fund youth violence prevention and intervention Programs: Youth violence is a significant problem that affects thousands of young people each day, and in turn, their families, schools, and communities. Youth violence and crime affect a community's economic health, as well as individuals' physical and mental health and well-being. Homicide is the third leading cause of death for youth in the United States. The Legislature should fund <u>culturally relevant youth development</u> programs.
- Support Small Business: The success of Latino small businesses is a critical component of Washington State's economic well-being. Small business owners must be able to have access to state and federal capital and operating funding.
- ➤ <u>Support Labor Apprenticeship Programs:</u> Close skill gaps and meet evolving diversity workforce needs by supporting continuous improvement and investment in apprenticeship programs that include a career pathway strategy for basic skill instruction, job training, and support services.

- SB5474 DO PASS: Ending outstanding legal financial obligations for youth and emerging adults trying to rebuild their lives 18 after involvement with the juvenile justice system.
   The Senate bill made progress (Feb 18 Public hearing in the Senate Committee on Ways & Means at 9:00 AM. Needs Executive action by Feb 24<sup>th</sup>)
- HB1479 DO PASS. Concerning restraint or isolation of students in public schools and educational programs. (Scheduled for public hearing in the House Committee on Appropriations at 1:30 PM Feb 23 Scheduled for executive session in the House Committee on Appropriations at 9:00 AM)
- SB 5601 DO PASS: Creating Youth Development Program under Department of Commerce to fund youth programming. (Feb 20 Scheduled for public hearing in the Senate Committee on Ways & Means at 9:00 AM)

- SB 5426 DO PASS: Relating to implementing the family connections program.

- HB1512 DO PASS. Providing tools and resources for the location and recovery of missing persons. (Feb 20 Scheduled for public hearing in the House Committee on Appropriations at 1:30 PM. Feb 23 Scheduled for executive session in the House Committee on Appropriations at 9:00 AM)
- SHB 1715 DO PASS. Enacting comprehensive protections for victims of domestic Creates a hotline to perform lethality assessments and a high lethality designation on domestic violence perpetrators.
   Requires electronic monitoring with victim notification technology to be available statewide.
   Requires the creation of a plan for a right to counsel for low-income survivors of domestic violence and a list of attorneys who specialize in representing such victim's violence and other violence involving family members or intimate partners.

- SB 5070 DO PASS. Concerning victims of nonfatal strangulation. (In Rules needs to be pulled for Senate vote)
   (PUBLIC SAFETY cont.)
- HB1501 DO PASS. Immediate family members of a homicide victim may receive 30 appropriate counseling to assist in dealing with the immediate, 31 near-term consequences of the related effects of the homicide. (In rules needs floor vote)
- HB1177 DO PASS: An act relating to a missing and murdered indigenous women and people cold case investigations unit. (In Rules Committee needs House Vote)

- HB 1455 DO PASS. Child Marriage only permitted until a person is 18 years old. Does not allow a parent to sign consent before the age of 18. (In Rules Committee needs House Vote)
- SB 5427 DO PASS. Creating a Hate Crimes reporting hotline. (Feb 20 Scheduled for public hearing in the Senate Committee on Ways & Means at 9:00 AM)
- SB 5033 DO PASS. Stronger penalties for crime of custodial sexual mis conduct. (In Senate Rules needs to be pulled for floor vote)
- SB 5477 DO PASS. Implementing the recommendations of the Washington state missing and murdered indigenous women and people task force. (Feb 20 Scheduled for public hearing in the Senate Committee on Ways & Means at 9:00 AM)
- HB1143 DO PASS AN ACT Relating to enhancing requirements for the purchase or transfer
  of firearms by requiring a permit to purchase firearms, firearms safety training, and a 10day waiting period, prohibiting firearms transfers prior to completion of a background
  check, and updating and creating consistency in firearms transfer and background check
  procedures. (Needs to schedule Executive Action in Appropriations)
- HB1240: DO PASS. Relating to establishing firearms-related safety measures to increase
  public safety by prohibiting the manufacture, importation, distribution, selling, and
  offering for sale of assault weapons, and by providing limited exemptions applicable to
  licensed firearm manufacturers and dealers for purposes of sale to armed forces
  branches and law enforcement agencies and for purposes of sale or transfer outside the
  state, and to inheritors. (In rules committee needs House Vote by March 8<sup>th</sup>)
- SB5078 DO PASS: AN ACT Relating to protecting public safety by establishing duties of firearm industry members engaged in the sale, manufacturing, distribution, importing, or marketing of firearms, ammunition, component parts, or accessories, to adopt and implement reasonable controls to prevent the diversion of firearms and related products to straw purchasers, firearm traffickers, unauthorized individuals, and individuals who pose a risk to themselves or others, to prohibit such firearm industry members from creating or maintaining a public nuisance, providing for investigation and enforcement by the attorney general, and creating a private right of action. (Needs Executive Action by Feb 24<sup>th</sup>)
- HB1024 DO PASS. Concerning labor and income of incarcerated persons. (Referred to Transportation Committee – needs hearing by Feb 24<sup>th</sup>)

#### **ENVIROMENTAL/CLIMATE**

 SHB 1216 DO PASS. Establishes an interagency clean energy siting coordinating council to be co-chaired by the Department of Ecology (Ecology) and the Department of Commerce (Commerce). (Feb 21 Scheduled for public hearing in the House Committee on

- Appropriations at 1:30pm. Feb 23Scheduled for executive session in the House Committee on Appropriations at 9:00 AM (Subject to change).
- SHB 1578 Improving community preparedness, response, recovery, and resilience to
  wildland fire health and safety impacts in areas of increasing population density, including
  in the wildland urban interface. (Feb 21 Scheduled for public hearing in the House
  Committee on Appropriations at 1:30 PM Feb 23 Scheduled for executive session in
  the House Committee on Appropriations at 9:00 AM)

# **IMMIGRATION** (LCA is in support of these bills)

- BUDGET REQUEST/PROVISO: Increased funding for immigration and naturalization services (budget provisos).
- BUDGET REQUEST/PROVISO Health Equity for Immigrants Campaign: this was originally
  going to be a bill but is now a budget proviso to increase access to health care access for
  state residents who do not qualify due to immigration status. More info

- SB 5109 & HB 1095: DO PASS: Unemployment insurance for excluded workers bill this would create a separate unemployment insurance program for workers who are ineligible for the current program based on federal rules b/c of immigration status. (Both bills in ways and Means needs hearing by Feb 24<sup>th</sup>)
- HB1470. DO PASS. Concerning private detention centers. Specifies conditions for the
  operations of all private detention facilities. Requires state and local agencies to inspect
  private detention facilities for compliance with food, workplace conditions, water and air
  quality, and performance audits. (Feb 22Scheduled for public hearing in the House
  Committee on Appropriations at 1:30 PM. Feb 24. Scheduled for executive session in the
  House Committee on Appropriations at 9:00 AM (Subject to change)

# **FINANCE** (LCA is in support of these bills)

- HB1477 DO PASS. Allows individuals filing as "married filing separately" to qualify for the
  Working Families' Tax Credit. (Feb 20 Scheduled for public hearing in the House Committee
  on Appropriations at 1:30 PM Feb 23 Scheduled for executive session in the House
  Committee on Appropriations at 9:00 AM (Subject to change)

- SHB1447 DO PASS. Strengthening the ability of assistance programs to meet foundational needs of children, adults, and families. (Feb 20 Scheduled for public hearing in the House Committee on Appropriations at 1:30 PM Feb 23 Scheduled for executive session in the House Committee on Appropriations at 9:00 AM (Subject to change)

#### LANGUAGE ACCESS

SB 5304 DO PASS. Requires the Department of Social and Health Services (DSHS) to
administer and develop oral and written tests to ensure language access providers are
fluent in English and a primary non-English language. Changes a requirement for when.
DSHS may offer spoken language interpreter testing. (Feb 21 Scheduled for public
hearing in the Senate Committee on Ways & Means at 9:00 AM)

#### **LAW ENFORCEMENT** (*LCA is in support of these bills*)

- SHB 1513 DO PASS Improving traffic safety. Limits officers' use of stops and detentions for non-moving violations and specifies additional process requirements for traffic stops.
   (Feb 21 Scheduled for public hearing in the House Committee on Transportation at 1:30 PM)
- HB 1579 DO PASS Creating independent Prosecutor in Attorney General office. (Feb 22. Scheduled for public hearing in the House Committee on Appropriations at 1:30 PM. Feb 24 Scheduled for executive session in the House Committee on Appropriations at 9:00 AM)
- SHB 1025 DO PASS Provides an additional cause of action against any other police officers who could have prevented the injury or aided in preventing the injury but failed to do so.
   (Feb 21Scheduled for public hearing in the House Committee on Appropriations at 1:30 PM (Subject to change). (Committee Materials)
   Feb 23 Scheduled for executive session in the House Committee on Appropriations at 9:00 AM (Subject to change).

#### **TRANSPORATION**

• **HB 1058** DO PASS. Streamlining the licensing process for a commercial driver's license by allowing the department to waive requirements for applicants that previously, allowing the license to be renewed online.
