Our Speaker is Lanette Pritchard, Owner of Colorado Horse Hemp

Lanette Davis Pritchard, grew up on a ranch and farm in La Junta, Colorado, participating in 4-H, Jr. Rodeos, High School Rodeos and FFA. She attended college at Otero Jr. College studying Ag Business, and rode for the OJC rodeo team.



She married Shane Pritchard, and together, they have been deeply involved in the horse industry for many years. In the early 2000's they produced large barrel races and provided Tanner Time, a laser timing system that broke down the complete time of the barrel racer's run into segments so they could see where they were gaining or losing time. They also taught barrel racing clinics with Lynn and Murray McKenzie across the country.

From 2008 to 2018, Lanette and Shane operated the Tanner Time Training Center and Cowgirl Candy Store in Rocky Ford, Colorado. They provided riding lessons

for all levels of riders, as well as producing barrel races and providing a great tack store for customers to learn more about saddle fit, bits, and horse supplements. During this time Lanette was also training and starting pleasure horses and barrel horses. She has competed in large barrel races, and professional rodeos, winning several titles in the barrel racing world. Due to her love for her horses and her students, she studied everything she could get her hands on about providing a better life for everyone in the horse world.

In 2019, Lanette and Shane downsized to two horses, that they raised and trained. They moved from Rocky Ford to Greeley, Colorado to start an engineering firm. Shane has a degree in mechanical engineering and a Professional Engineering license. Lanette's connection to hemp and CBD came about through the engineering company. During their time working with hemp growing farms to engineer green houses, Shane learned that they had no idea how to process the hemp after they had grown it. Shane has extensive experience in harvesting and processing agricultural products through his former position as chief engineer for Oliver Manufacturing.

Trailer Safety Inspections

According to our agreement with the Larimer County Sheriff's Office, we provide safety inspections for all team members annually. We also invite any other Larimer County Horseman's Association members or members of Northern Colorado Back Country Horsemen to take advantage of these inspections. There is no charge for the inspections.

We will also try to set up a friendly driving course. For drivers who do not have a partner, we will assign one to you for today.

The 2022 schedule includes two trailer safety inspection dates. Why? All evacuation team members **MUST** have a safety inspection for a trailer to be used for an evacuation. However, not all team members can attend on one or the other date. If you cannot attend on one of these dates, be sure you attend on the other.

These sessions are open to any LCHA member.

TIP: Be sure to test your emergency brake battery to make sure your emergency brake will stop your trailer if it becomes disconnected to your truck while en route.

Policies and Procedures

All new evacuation team members must attend this session. If you missed this session in a previous year (for whatever reason), attend this session. If you would like to review the policies and procedures we use, or if you have questions or comments about them, please attend. Bonnie will send an ZOOM invitation to this session to all team members, including newbies.

Horse Loading

Horse loading is an annual event for team members. It is a valuable day for people and horses.

We practice loading horses at least once each year as an evacuation team.

Surprise: This year, we will have the extra pleasure of working with a trailer into which we can load our horses into the side or the rear.

All evacuation members attend this session: drivers **and** partners (after all, partners may need to assist drivers when loading horses during a call-out..

For new members, here is how it works:

- Each driver brings one trailer and one horse to the training area.
- We receive training, and other information as necessary.
- Each person loads each horse into every trailer.

The session usually takes about 2 hours.

Qualifications

- Must be a member of LCHA
- Patience with people and horses

- Know the trail and its restrictions

Trail Ride Leader Training

In years past LCHA trail rides developed a bad reputation. Participation dropped to two or three riders – six riders was considered a big ride.

We developed a training program for ride leaders based on the philosophy that every rider was there to support the rider that needed help at the moment. LCHA's trail ride reputation improved. Attendance improved.

The training program includes classroom (or ZOOM) instruction plus mentoring on actual trail rides.

Bonnie May, our Trail Ride Coordinator, is currently setting up a date, time, and method (in person or ZOOM) for the classroom Trail Ride Leader training. It's not too late. Contact Bonnie May at 970-217-1113 in you would like to join the class.

Texting Service for LCHA

In November and January we had a situation in which we had to cancel the LCHA educational meeting at the last minute because of blizzard and presenter illness. This led to 3 of us frantically making calls to all members to cancel before they left home for the meeting.



At the Board meeting we thought there had to be a better way. I have been researching texting services. We thought that if we could send out a text, people would get it quickly and we could

reach many people at once. I have learned that what we are talking about is mass or bulk texting and there are companies that provide this service.

In mass texting, a text is sent to a large group of cell phones by a central administrator. Users can reply to the text. The reply goes back to the administrator and is not seen by the other members of the group.

I realize that not everyone has a cell phone and we will still call those people individually.

The best service I found was a company called Text-Em-All. They are willing to work with small non-profits such as ours and have a special pricing for it. At this point we have 75 memberships which include over 100 individuals. They will also allow us to specify subgroups. So if a text needs to go just to the Evacuation Team, we can do that.

We would use the texting service to notify of an emergency, or send out meeting reminders. We would not abuse it by flooding you with texts. Text-Em-All does not want texts going to people who do not want them.

Therefore, I need each LVCHA member to send me an email (templetb@gmail.com) and give me the following information.

1. Say: Opt in or Opt out
2. Your name

3. Your cell phone number. If this is a membership with more than one person, give me the names and cell phone numbers of each.
4. If you are Opting out, your name. It would be helpful if you include your reason for opting out, but that is not required.

Over 40 people have opted in to this service. We will begin testing the service soon.

Hopefully, this service will allow us to serve members better. Please remember to check your texts before each meeting.

Why

Why?

If we need to cancel an event, your ride leader can get in touch with you to let you know before you drive to the location. You won't use gasoline or time waiting for an event that isn't going to happen. Also, your event leader needs to know if anyone is coming: If no one signs up, the leader may cancel or reschedule the event. And, if you have any special concerns or circumstances (for example, it is your horse's first ride with a group), your leader can plan to deal with the situation in the best possible way.

What's the Deal with "Limit"?

Wilderness areas, properties owned by the city of Fort Collins, and Red Mountain Open Space have a "12-heartbeat rule": a group cannot include more than 12 heartbeats when using trails in these areas. When riding our horses, the rule limits our groups to 6 riders (plus 6 horses with hearts) to meet the 12-heartbeat rule. However, if we have significantly more than 6 riders who want to ride, we can split them into 2 or more groups, each group including 6 riders (1 ride leader plus 5 others). The second group must leave the trail head 20 to 25 minutes after the first so that they do not merge with the first group.

When "Limit" is 4 horse trailers, it means that the parking space can hold only 4 horse trailers (tightly packed). However, we encourage "trailer pooling" if more than 4 people want to go on the ride. Actually, we encourage "trailer pooling" for any ride. The benefits are obvious.

Lunch?

For all rides except the Christmas Caroling on Horseback, bring your lunch (unless your ride leader tells you otherwise). You will have lunch somewhere on the trail.

LCHA Educational Programs

LCHA offers a program meeting on the First Thursday of each month, except June, July, August, and December. All members are invited, and the public is invited, to any program meeting. We meet at the McKee 4H Building at The Ranch.
