Who benefits from Precision's Healthcare Technologies?

Because we are present in 17 sectors of healthcare and consumer health, and already providing connections between them, the opportunities are endless. In fact, we have over 250+ case specific graphic PDFs and 150+ Al videos to outline these many opportunities to make a difference!

Because there is no upfront or out of pocket costs, no operational or workflow changes needed, and a profit guaranteed, together we have a "Blank Check" to make exponential changes for the better. Let's check out a few of these options you may not have considered. Thank you in advance!

- **Consumers & Patients** They need access, options, pricing, and the ability to instantly connect to the desired service. This requires them to have access and control of their health records. Only Precision can provide either of these solutions.
- 2
- **Hospitals with Physician Employees** One hospital system had 213 employees missing \$42 million in mandated services that they are being penalized for not taking. Overnight fix!
- 3
- **Groups & Organizations** On just the first 10 providers in alphabetical order, one group of 704 providers was missing \$353K EACH in required services. The same company spends \$200K on data, has 70 people on patient engagement, and 50 people on RAF Scores. Without Precision they are failing at great expense.

- **Data & Al Generative Workflow** Even Google maps can't provide direction without a destination. Because Precision's platforms update ongoing medical necessities, and then connect to those services, we can make these companies the stars of the show! Otherwise, Al generated workflows are just "road construction work", or making a bad road better with no real aid.

- **EHR Companies** While we're at it, our model not only allows EHR companies the ability to share in our revenue, but our consumer and patient health access and control initiatives allow them to offer a new paperless upgrade to all their present clients.

ACOs, Medicare Advantage and Shared Risk Programs – We separate the patient population to apply different AI generated care coordination escalation that delivers twice the number of services, for half the cost and no denials due to our validation and documentation of medical necessities. We also share our fee for service revenue back with your organization.

Payers – Again, we must deliver twice the number of services, for half the cost and no denials. Payers need current data for Health Risk, General Anxiety & Depression, and Social Determinants of Health for their covered members. We then share this information back with their network providers with new "Al Triage, Care Coordination and Navigation Guiderails" in place to assure the very best, efficient and cost productive delivery.

Independent Physicians Associations/IPAs – These organizations are always trying to provide value adds while struggling for revenue. This solution is a tremendous strategic collaboration to serve all needs and provide a market differentiator. We share our revenue with all partners!

Revenue Cycle Management/RCM – If the typical provider is missing out on \$300K in compliance mandated services, you become the hero for your practice client while generating effortless new revenue for your company.

Virtual Care & Telemedicine – Providers don't have the staff or time bandwidth to address serving \$300K in recovery of these newly discovered missed mandated services. You are the perfect solution to filling this vital staff and car gap. If you only served moderate risk patients as an advanced triage for the practice, everyone wins big, especially the patient who now doesn't have to wait to receive care. Prescription refill visits, referrals or same day care is now possible.

Pharmacy – Walgreens invested \$6.2 billion in Village MD for pharmacies to be able to provide provider services. The model closed in 2023 due to significant operational losses. Our model does the exact same thing at no cost, while enrolling every consumer and patient into health records ownership. Again, logic prevails over technology and business solutions.

Ancillary Service Providers – About 70% of this missed mandated revenue should be coming to you yet never connected. Our electronic outreach and enrollment remove the human checklist component and greatly increases those who actually get access to care where medical necessity has been pre-validated by our platform. NOTE - Typically, your services only apply to 4% to 32% of the practice. Introducing Precision allows you to share our revenue on 100% of the patient population while increasing your program participation by many multiples.
