## Here's What & How it Happened!

- 1 Our original updated Precision Health Access phone app was built for and with T-Mobile as a subscription model for health access.
- 2 We then connected those interested consumers to their own providers or the Zocdoc network of local area physicians.
- 3 Our updated app is a thousand times more advanced, and we have MANY provider networks.
- 4 On June 25, 2025, Precision HC Trust (PHCT) signed a 50/50 Joint Venture with Milliman CareFlow IQ to, for the first time in history, provide access and control of health records to consumers and patients via our provider networks. This is the beginning of fully connected paperless healthcare.
- 5 On July 22, 2025, 27 days later, PHCT agreed in principle to a Strategic Altruistic Collaboration with Google Cloud Healthcare (GCH).
- 6 For 16 months GCH kept up with Precision's progress and wanted to help facilitate our Patient Records Ownership initiatives and secure those personal health records for consumers.
- 7 We got their attention when we were the first ever to move data from our phone app to EHRs.
- 8 Google Health was a primary pioneer in these efforts to democratize health records. Like Google Wallet, GCH doesn't access or control the data, only secures it from outside attacks.
- 9 An inclusive corporate citizen, Precision works with existing health and wellness apps, creating a brandable [Preventive Health App](#) as a template others can adapt and brand as their own.
- 10 Both our PHA and these template apps will offer organizations and developers access to what we call the "Google Secure Health Records Vault" option for the data security.

## Generative AI & Other Takeaways from Our Milliman & Google Meetings

- 1 Most generative AI coming to market is geared toward organization, provider and clinical workflows.
- 2 If those systems don't partner with Precision's output, these organizations will simply continue to produce failed outcomes, but in a much faster and more efficient way.
- 3 Even Google Maps needs a destination to begin. In healthcare technology, Precision provides that destination and is updated in real time for each individual patient from within the results of each subsequent encounter.
- 4 Precision will provide the destination and targets, and these brilliant AI companies can connect them. The goal is the opposite of "Garbage In, Garbage Out," but it takes us all working together invisibly in the background. Like a great official at a sporting event, you should never see us.
